

WAIVER AND RELEASE: USE OF PERSONAL VEHICLE TO TRANSPORT STUDENTS FOR SCHOOL ACTIVITIES

The undersigned hereby acknowledges the use of his/her personal vehicle for the transportation of students for school activities is entirely voluntary and to be exercised in the discretion of, and with the judgment of, the student's parent/legal guardian. The undersigned acknowledges that students riding in the vehicle have completed all permission forms and that such students' parents have been informed that students will be riding in the personal vehicle of the undersigned.

The undersigned further acknowledges he or she has a valid driver's license and will be the driver of the vehicle for transportation to and from the activity and that the vehicle being used for said transportation is owned by the undersigned. The undersigned also acknowledges that his/her personal insurance will be applied in the event of any accident or other event that adversely affects the occupants of the vehicle in any manner. The undersigned agrees and certifies that he/she has maintained, and will do so at all times when transporting students, a valid driver's license and legally required insurance coverage, which must include coverage for bodily injury, property damage and comprehensive.

I UNDERSTAND THAT I AM SIGNING AND AGREE TO A FULL AND COMPLETE WAIVER AND RELEASE OF ANY AND ALL LIABILITY THAT BARS MYSELF AND MY HEIRS AND ASSIGNS, AGENTS AND REPRESENTATIVES, FROM ANY RECOVERY FROM THE PIKE COUNTY R-III SCHOOL DISTRICT (THE "DISTRICT" BEING DEFINED TO INCLUDE THE DISTRICT AS A LEGAL ENTITY, BOARD OF EDUCATION, BOARD OF EDUCATION MEMBERS, ADMINISTRATORS, AGENTS, REPRESENTATIVES, OFFICERS, COACHES, CONTRACTORS, STUDENTS AND EMPLOYEES – WHETHER IN AN OFFICIAL OR INDIVIDUAL CAPACITY) FOR INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO ANYONE OR ANYTHING, INCLUDING BUT NOT LIMITED TO MYSELF, THE STUDENTS, VEHICLE OCCUPANTS, THE STUDENTS' PARENTS/LEGAL GUARDIANS, AND/OR ANY THIRD PARTY, ARISING IN ANY MANNER FROM MY TRANSPORTATION OF STUDENTS FOR SCHOOL ACTIVITIES. I ACKNOWLEDGE THAT THIS WAIVER AND RELEASE APPLIES TO ALL ACTS OR FAILURE TO ACT, WHETHER INTENTIONAL, RECKLESS, OR NEGLIGENT, ON THE PART OF THE DISTRICT (AS THAT TERM IS DEFINED ABOVE). I UNDERSTAND THAT BY SIGNING THIS WAIVER AND RELEASE, I AM EFFECTIVE IMMUNIZING THE DISTRICT (AS DEFINED ABOVE) FROM ANY AND ALL LIABILITY.

I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS THE DISTRICT (AS DEFINED ABOVE) FOR ANY AND ALL LIABILITY RESULTING FROM ANY INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO ANYONE OR ANYTHING, INCLUDING BUT NOT LIMITED TO MYSELF, THE STUDENT, AND/OR ANY THIRD PARTY, ARISING IN ANY MANNER FROM MY TRANSPORTATION OF STUDENTS FOR SCHOOL ACTIVITIES. ACCORDINGLY, I WILL NOT BRING ANY LEGAL ACTION OR ASSERT ANY CLAIMS, WHETHER IN A COURT OF LAW OR OTHER FORUM, AGAINST THE DISTRICT (AS DEFINED ABOVE) FOR INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO ANYONE OR ANYTHING, INCLUDING BUT NOT LIMITED TO MYSELF, THE STUDENTS, VEHICLE OCCUPANTS, THE STUDENTS' PARENTS/LEGAL GUARDIANS, AND/OR ANY THIRD PARTY,, ARISING IN ANY MANNER FROM MY TRANSPORTATION OF STUDENTS.

I SIGN THIS WAIVER AND RELEASE OF LIABILITY VOLUNTARILY AND WITH A FULL AND COMPLETE UNDERSTANDING AND KNOWLEDGE OF ITS CONTENTS, AND I AGREE TO BE BOUND BY IT.
