FROM THE DESK OF BETH HENCH

We were thrilled to welcome our students, teachers, and staff back for the 2021-2022 school year. Although the year has not quite been the return to normal that we hoped it would be, I am so proud of the work that continues to be done on a daily basis. During the beginning of the year professional development, our teachers spent some time building with Lego to recognize the importance of each piece of the puzzle that makes us successful. I want to again thank all of our puzzle pieces – students, teachers, administration, staff members, families, and community members – for the hard work and support that has been evident throughout the start of the year. This will be another great school year because of our collective dedication to doing whatever it takes to ensure student success in our classrooms and beyond our walls.

I would be remiss if I didn't take a moment to remind our community that November 2 is Election Day. Ayersville has two **RENEWAL** levies on the ballot: a 1.6 mill natatorium levy and a 1% income tax levy. These levies are **NO NEW MONEY** for our district. Over the past several years the landscape of Ayersville has been adjusted to account for losses in tax dollars, adjustments to state aid, and legislative changes. The opportunities we have been able to provide to students have suffered - in one way or another - due to changes we have made as a result of our financial situation. The income these renewal levies will bring will allow the district to at least maintain our current programming and continue to offer the best possible education we can for our students. <u>Help Wanted</u>: There is a shortage of individuals willing to serve as substitutes in school buildings across the country. Ayersville is no different. We need the support of our community more than ever. Even if you are able to help one day a week, your services would be greatly appreciated!

- Classroom teacher: A person can be a substitute teacher if they have a bachelor's degree in any field OR Senate Bill 1 is expected to expand individuals allowed to serve as a substitute to any high school graduate. Anyone interested in becoming a substitute must apply for the appropriate license and must be able to pass a criminal background check.
- Bus drivers (regular route and substitutes): Bus drivers help with extracurricular activities, field trips and/or a regular morning or afternoon route. Certification requires the completion of attending a preservice class, a written and driving test, CDL license, a medical physical exam, drug test, BMV check of driving record, and a background check. Cost for training will be paid for by the district

for any individuals who serve as a bus driver for Ayersville Local Schools.

• Cafeteria: Help is needed in the cafeteria for the hours of 9:15 a.m. − 2:00 p.m. Anyone interested in becoming a cafeteria substitute must be able to pass a criminal background check.




2020-2021 FINANCIAL RESULTS – GENERAL FUND

The General Fund is used for the daily operations of the school district. Salaries, benefits, utilities, transportation, and other operational items are paid from this fund. Following is a summary of the results from 2020-2021 (FY2021), which ended June 30, 2021.

Revenue for the General Fund totaled \$8,167,730, which was 7% lower than FY2020. This year's decrease was due to decreased property tax collections. Some properties within the district were granted tax exemption and a three-year refund was given. The district was notified in June 2020 that the payment that we received in September 2020 would be significantly less due to the refunds given. While this was a dramatic loss, it will only have a major effect on local real estate tax for one year. Overall revenue was down including real estate tax, tangible personal property (TPP) tax, income tax, and all other revenues. The only increased revenue was to state aid which was from the partial restoration of state funding cuts from FY2020. The percentage of each major revenue source for the General Fund in FY2021 is shown below:



Expenditures from the General Fund totaled \$9,132,312, which was a 4% decrease over what was spent in FY2020. The split between categories is different from prior years. ESSER funds (federal funds provided for relief from the extra expenditures related to COVID) were used to offset some salaries and benefits lowering that percentage. An increase to the advances to other funds was also due to the ESSER funds. Cuts were also put in place in FY2021. In general, expenditures were down in salaries, benefits, purchased services, supplies and materials, and capital outlay. As schools are a "people business", the majority of the budget in schools each year is allocated to salaries and benefits. The graph below shows the breakdown of last year's expenditures by major category:

The district was able to lower expenses by implementing cuts and offsetting some costs with federal funds. Unfortunately, the loss in revenue was greater than the amount saved by lowering expenses. As we begin FY2022, the Tangible Personal Property (TPP) reimbursement phase-out will result in the loss of approximately \$56,782 in additional revenue in FY2022 and \$66,821 in FY2023. FY2025 will most likely be the last year of this state reimbursement. The Fair School Funding Plan (FSFP) was included in the biennial budget for FY2022 and FY2023 with a projection of increased state revenue in the amount of \$521,402 in FY2022 and \$888,981 in FY2023. The future of the FSFP is not guaranteed past FY2023. Even with the increase in state funding, the stability of the district lies in the continuation of local real estate and income tax.

ELEMENTARY UPDATE

The school year is off to a great start at Ayersville Elementary. Students have been busy learning our school and classroom expectations. Teachers are continuing to utilize Google Classroom with their students. This is another wonderful way for families to stay connected with teachers and the expectations of the classrooms. Our Mindset for October is Everything is Possible. Students are learning that by staying positive and setting high expectations for themselves, anything is possible.

The 5th and 6th grade students went on a field trip sponsored by the Soil and Water Conservation District, and Kindergarten and 2nd grade students ventured to Leaders Farms. Students in K-3 learned about fire safety and fire extinguishers through the support of our local fire fighters!

Third graders took the Ohio's English Language Arts State Assessments on October 19 and 20. These results will be sent to families when they arrive in the district.

HIGH SCHOOL UPDATE

It has been a fantastic start to the 2021-2022 school year! There have been so many outstanding happenings within our classrooms on a daily basis that we are unable to list them all in one update! That is just one of the many reasons that I encourage each of you to download the Ayersville Local Schools App!

We have weekly news articles from teachers as well as daily posts on our Live Feed featuring quick updates from nearly every teacher!

In addition to the updates from within the classroom, our Video Production team has revamped how our daily announcements look. The students have been working hard on producing a daily newscast that allows us to not only share information, but to also highlight the positive that is happening in and around the school.

As a building, our theme this year is: Attitude's a choice: What's yours? The students hear this message on a daily basis following the Pledge of Allegiance. As a staff we are challenging our students to take a deeper look into their own choices towards their attitudes. Are they choosing to find the positive and help to spread it? Do they need somebody to lean on during a particularly tough day? Each day students are encouraged to make somebody else's day better, no matter how small of an improvement that is! Our staff has worked these thoughts and challenges into their lessons throughout the High School building this year.




