#### REPORT OF BOARD COMMITTEES OR REPRESENTATIVES

Mr. Pittenger's and Ms. Ferguson's reports stand as read.

Dr. Jancek announced that the first round of interviews for the Superintendent will be held on October 27<sup>th</sup> beginning at 4:00. He has a committee of 15 splitting into 3 groups of 5 to speak with the candidates. All 5 candidates have been informed of the date and time. He will have a meal catered in and the interviews will be held in the DTHS Library and upstairs classrooms. Once the interviews have been completed, the committee will meet and decide on which 2 or 3 candidates they would choose for final interviews by the Boards.

He will contact Peoples National Bank of Kewanee to get more information on current CD rates, but at this time feels that we will probably renew this CD for another 1 year term due to the uncertainty in the market during the pandemic.

Dr. Jancek forwarded a request from the FFA to attend the National FFA Convention in Indianapolis, IN from October 27<sup>th</sup>—October 30<sup>th</sup>.

Moved by Berta, seconded by Scheuer, to approve attendance at the National FFA Convention in Indianapolis, IN, as presented. Roll call. All voted aye. Motion carried.

Dr. Jancek asked the Board members who are attending the Joint Annual Conference in Chicago in November if anyone wanted to step forward and take a delegate position. All Board members declined.

Mr. Pittenger introduced Lora Weir, a senior who is requesting early graduation, pending successful completion of graduation requirements. Weir has indicated that she will come back to walk at graduation.
