Hanson moved to approve the contract between the Stanley County School District #57-1 and Rise Athletics, LLC to begin on November 1, 2021, and continue until the 2024 South Dakota High School gymnastics state tournament concludes, seconded by Fosheim. All in favor. Motion carried.

Homecoming was discussed and how changes could be made in the future to include elementary at the pep rally. Discussion regarding the parade was also had.

Kleinsasser moved to move the monthly school board meetings to the second Wednesday of the month starting in November 2021, seconded by Hanson. The November meeting will be held at the Cheyenne School. All in favor. Motion carried.

Fosheim moved to use ASBSD's online policy service program for Stanley County school board policy review and hosting purposes, seconded by Hanson. All in favor. Motion carried.

Terri Mehlhaff, Elementary Principal, updated the board on the elementary. Britany Willis received September Elementary Staff of the Month. Currently working on a rewrite of the JK Report Card which will be based more on Academic Readiness. Mrs. Mehlhaff reported that the chromebooks, iPads and promethean boards are all working well at the elementary and Cheyenne. The PBIS team is continuing to work towards parent and community outreach. Superintendent Baldwin updated the board on the ASBSD Policy review. Baldwin is setting up meetings with the local legislatures who are preparing for this year's session. Baldwin who has been attending Fort Pierre Development Committee meetings updated the board that the tree moving will be November 26 and Stanley County students will be caroling on December 4th at 6:30 P.M. Dalsin Roofing has offered to do a free estimate for Stanley County. There will be a Veteran's Day program on November 11th at 2:00 P.M. Baldwin gave the board a couple of evaluations to use for him.

Hanson moved to declare the Board in Executive Session for SDCL 125-2 (1) Personnel, (2) Students Matters at 7:06 P.M., seconded by Fosheim. All voted in favor. Motion carried.

Cronin declared board back in open session at 7:34 P.M.

Fosheim moved to authorize Business Manager to offer Jacob Kvigne a Letter of Intent as Middle School Boys Basketball coach in the amount of \$2,819.95 effective for the 2021-2022 school year, seconded by Hanson. All in favor. Motion carried.

Hanson moved to authorize Business Manager to offer Jennifer Milliken a Letter of Intent as Teach Mentor in the amount of \$1,193.55 effective for the 2021-2022 school year, seconded by Kleinsasser. All in favor. Motion carried.

Fosheim moved to authorize Business Manager to amend Amber Garrett's contract to reflect MA per certified negotiated agreement in the amount of \$48,170.00 effective for the 2021-2022 school year, seconded by Hanson. All in favor. Motion carried.

Hanson moved to accept the resignation of Shannon Hallock as Special Education Teacher effective September 23, 2021, and a \$1,200 contract breach per 2021-2022 certified negotiated agreement, item IV, section nine, seconded by Fosheim. All in favor. Motion carried.

Hanson moved to approve open enrollment application #572122028 and #572122029, seconded by Fosheim. All voted in favor. Motion carried.

Hanson moved to deny open enrollment application #572122030, seconded by Kleinsasser. All in favor. Motion carried.

Fosheim moved to adjourn meeting at 7:37 P.M., seconded by Kleinsasser. All in favor. Motion carried.
