Information Items:

Student Board Representation Selection: Interviews for three student candidates for the school board took place. The Board voted to accept all three candidates: Junior: Madeline Schroth. Seniors: Riley Dreier and Ania Hoffman.

Board In-Service: John Bales, Executive Director of WASDA, gave an overview of the fundamental purpose of the school board as representatives of the community to define outcomes, set policy and vision to support the Superintendent.

ESSER Funds Update: Mr. Krizan provided an update on the status of ESSER II and III funds for the school district.

Action Items:

Raptor Program: The Raptor Visitor Management program allows the schools to screen visitors to our buildings. Behavior Support Position: Mr. Krizan presented a job description for an additional position to support our teachers and students when it comes to student behavior, K-12. The staff person would proactively work with students and teachers. The Board approved the position as presented.

Resignation: Nicole Hartleban, Human Resources Director, presented the resignation of – Special Education Teacher, Brianna Pfeiler, Hillcrest. Board accepted the resignation.
