FCCLA Student Presentation:

Bus Bid:

Mr. Stumpf presented a Bus Bid to the Board of Education. This bid would be ordering the scheduled bus purchase now for 2022-2023. The State Bid expires October 31, 2021 and the build lead time is 6-9 months. By placing the order now, we would be locking in a lesser price and would not take possession until the next fiscal year.

A motion was made by Jill Ade and seconded by Charisse Nurnberg to approve the order for a new route bus for 2022-23 at the state bid price from Kansas Truck, not to exceed \$90,000. Carried 6-0

Out of District Application:
