1.	All membership dues must be paid in advance and on time		
2.	Membership is not transferable to others		
3.	Only fitness center card holders are allowed in the fitness center		
4.	Children between the ages of 13 and 18 may use the fitness center outside of school hours if the are accompanied by at		
	current fitness center member who is responsible for the child		
5.	No children under the age of 13 are allowed in the fitness center ANY TIME		
6.	The Floodwood School is not responsible for any lost or stolen property when using the fitness center. Do not leave valuables unattended when using the fitness center.		
7.	Your valid membership card must be with you at all times when you are using the fitness center		
8.	Anyone using the fitness center without checking in properly or allowing access to non-members of the facility will have their membership suspended and their membership fees forfeited		
9.	The Floodwood Fitness Center may only be used during the established hours of operation		
	You must be post-high school-aged and 18 years or older to join. No children under the age of 13 are allowed in the fitness center		
	If you have a medical condition inhibiting exercise, you will take the necessary precautions and assume any and all risks Exercise is voluntary performed at your own risk		
	3. If you should incur an injury at the Floodwood Fitness Center, you acknowledge that it is your responsibility to seek appropriate care and that the school will not be held liable		
14.	No food or drinks other than water may be taken into the fitness center		
15.	Pants/shorts, socks, shoes and shirt must be worn at all time. Changing should occur in the restrooms, not the fitness center		
16.	Street shoes must be removed before using any fitness equipment and only tennis shoes should be worn		
	If others are waiting to use equipment, please limit your time on any one piece of equipment to no more than 30 minutes.
