SUPERINTENDENT'S REPORT

The recent replacement of the area gas line (by Gas Company) has caused problems with area residents. The gas company is required to put pressure on the line to find leaks and if there are leaks found, the gas will be shut off until the leak is fixed. Today the gas company decided to check the school lines, even though we requested them to check the lines when we had a break in school days. There were leaks discovered and the gas has been shut off. What this means, we have no hot water or a way to cook meals for our students until the leaks are fixed. We have arranged for the food and Miller's will be here tomorrow to start fixing the leaks. How much this will cost is unknown and we will keep the Board up to date.

The Port Authority has asked the Board to allow for the 6 parcels of land in Wolf Creek to be valued for half their worth and taxed at that worth. This has been discussed in prior meetings. A formal resolution will be presented to the Board at the November meeting.

Mr. Baldwin has asked a local contractor and Energy Optimizers about adding air conditioning at the High School. The District will be using ESSER money to make this update.

OASBO conference will be from November 7-9 and Mr. Roger Doak and I will be attending.

The Band Booster Chicken BBQ held on October 9th was sold out.

Speakers at the football field have been replaced.
