20% Set Aside to Address Learning Loss

How the LEA will use the funds it reserves under section 2001(e)(1) of the ARP Act to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive after school programs, or extended school year. At least 20% of the ARP ESSER III budget is required to be spent in this area. This includes but is not limited to:

Summer school to address standards lost during lack of instruction	\$20,000 (2021-2022, 2022-2023, 2023-2024)

Chromebooks to provide access to Google Classroom and other instructional resources required to continue access to instruction quarantines and infection	\$100,000
Replacement of wifi, server, and switches to provide continuous access to online learning applications and benchmarks allowing staff the necessary tools to address learning loss	\$115,000

80% of ESSER Funds dedicated to Allowable Uses

Meeker Public Schools will spend the remaining ARP-ESSER III Funds, consistent with the allowable uses authorized in section 2001 (e) (2) of the ARP Act.
