Allen Crist, Barb Schaible, Amy Finn, Diane Haring and Lisa Walters answered roll call. Member Diestelmeier and McLane were absent. President Crist announced a quorum was established. Also present: Superintendent Brad Albrecht, Principal Mike Foltz, Principal Beau Buchs, two representatives for the RREA and several students.

After approval of the December Agenda, which includes the consent agenda and consensus items, the Board took the following action:

Approved regular and executive session minutes from the November 18, 2019 board meeting and destruction of the executive session audio minutes from April 16, 2018.

Reviewed and accepted the Treasurer, Investment and Activity reports. The Board authorized and approved the payment of \$705,036.82 for bills and payroll.

- -Mrs. Kuzniar, along with local churches, are assisting 25 students through the Nutrition Club Program.
