# AGENDA ITEM 09-49 CATEC SCHOOL SUCCESS PLAN

Mr. Bonham discussed CATEC's school success plan and reviewed the focus from last year to this year by highlighting the five initiatives. He reviewed the data provided including the students' assessment and industry certification pass rates. CATEC is assessing students

more and providing more credentialing opportunities which are critical for employment purposes such as ServSafe, OSHA 10, or CPR. The State mandates that 50% of students be tested in CTE programs; CATEC tests 81% so that exceeds the minimum. He also discussed the English SOL results and CATEC's goal of a 100% pass rate for this year. Projected 2009/10 enrollment is now at 424 students and he feels as though CATEC is "back on track." Mr. Bonham gave specific enrollments breakdowns for the various programs and talked about non-traditional enrollment.

The student-centric approach is teacher-led and teacher-fostered with students engaged by using technology and resources. CATEC has done a lot with innovative technology by integrating and fostering a skill set that all students need to have. Mr. Bonham explained the work being done with the staff so that they can support the students to use technology, engage students and add value, and learn how to find the resources that are available. CATEC students are creating student portfolios (which Mr. Bonham explained in detail) and they are using Google applications such as Google docs, sites, and forms. Mr. Bonham reviewed workplace skills and explained how they are being measured using the rubric. The process is now automated and the students own the evaluation for this process, but it is fostered by the instructor. Mr. Bonham intends to use something similar with PLCs this year with the hope that the data will drive instruction.

### AGENDA ITEM 09-50 CLOSED SESSION
