

H. NEW BUSINESS

1. BOCES Administrative and Capital Budget Presentation

Mr. John Harvey, Broome-Tioga BOCES Chief Operating Officer presented the 2020-2021 BOCES Administrative and Capital Budgets. He stated the Administrative Budget remains the same from last year. Mr. Harvey reviewed the historical percentage increase and/or decrease in the administrative budget. He discussed the District's apportionment by Resident Weighted Average Daily Attendance (RWADA), and stated the RWADA is up for the Whitney Point District. He reviewed the Capital Budget Components and stated the projection for 2020-2021 is a slight increase.

2. Introduction of New Capital Project Planning Team

Chris Gray and Pat Griffin from Turner Construction Company and Ed McGraw from Ashley McGraw Architects introduced themselves and briefly described some of their thinking and strategies around the district's next capital project. They both expressed their excitement and gratitude for being selected to work with the district and for being awarded this opportunity.

3. TRA Strategic Plan Initiatives

Mr. John Whalen, TRA Principal, and Mrs. Julie Lamuraglia, TRA Assistant Principal, presented the current TRA Strategic Plan Initiatives. Mr. Whalen stated the TRA focuses on meeting the needs of the whole child in the areas of attendance, academics, social emotional learning, discipline and response to intervention. Mr. Whalen and Mrs. Lamuraglia explained in detail the approach to each area and how it is implemented with the 4th-8th grade students in the Whitney Point School District.

4. 2020-2021 Budget Presentation

Dr. Follette gave a 2020-2021 Budget Overview Presentation. She discussed in detail the number of students, various programs and numerous employees required to educate the students and operate the district.

She presented the current budget goals. She reviewed the distribution of revenue within the district and explained state aid makes up approximately 72.78% of the budget and the tax levy makes up

approximately 22.05%, while other revenue sources make up the remaining percent. She also discussed the distribution of expenditures. Dr. Follette confirmed the Board of Education would maintain the same goals while developing the 2020-2021 Budget: focus on education, build a sustainable budget, and develop a reasonable tax levy within the applicable regulations.

Dr. Follette provided an overview of the current budget. She discussed the Financial Component of the Governor's Executive Budget Proposal. She stated in recent years, the Governor has proposed collapsing certain expenditure driven aids into Foundation Aid, the primary formula-driven aid. She stated the proposal for 2020-2021 is the first year that this is shown as such in the aid runs. She stated ten expenditure driven aides were collapsed into Foundation Aid. She stated the five that are relevant to our district are BOCES aid, textbook aid, software aid, library materials aid and computer hardware aid. She explained for 2020-2021 the calculation of each aid would occur as in the past but then would be paid as foundation aid. She stated in future years, these aids would no long be calculated and would be included in the Foundation Aid base — essentially frozen for all time. Dr. Follette stated districts would no longer see an increase in aid even if expenditures related to these areas increase. She reviewed the projected 2020-2021 expenditures resulting in a current budget GAP of \$661,102. She explained it is very early in the budget season and we will continue to monitor the Governor's budget to see what changes there might be from the initial proposal. She stated the next Budget Update will be at the March 17th Board Meeting.

Shall the following resolution be submitted to the voters:

RESOLVED, that the Board of Education of Whitney Point Central School District, located in the counties of Broome, Chenango, Cortland and Tioga, New York, is hereby authorized to purchase three (3) new 71 passenger diesel buses at a cost not to exceed (\$129,557.00) each for a total not to exceed (\$388,671.00), and one (1) new 5 passenger gas Dodge Durango (or equivalent) at a cost not to exceed (\$38,685.00), and to expend therefore not to exceed the estimated total cost of (\$427,356.00) including incidental expenses in connection therewith; and that such sum, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation

of such tax, the Board of Education is hereby authorized to issue bonds or other obligations of the School District in the aggregate principal amount of up to (\$427,356.00).

RESOLVED, upon the recommendation of the Superintendent of Schools that:

A public hearing, budget vote, election of board members, and consideration of submitted propositions shall occur as stated in the NOTICE OF SCHOOL BUDGET HEARING AND ANNUAL BUDGET VOTE, as set forth below, and it is further,

RESOLVED that the NOTICE OF SCHOOL BUDGET HEARING AND ANNUAL BUDGET VOTE is approved and shall be published as required by law.

NOTICE IS HEREBY GIVEN that the Annual Meeting of the inhabitants of the Whitney Point Central School District, at which time will occur the Budget Vote, the Annual Election of Board of Education members, a vote upon certain propositions, including a proposition for the purchase of buses, and to authorize the levy of taxes will be held at the High School Cafeteria, 10 Keibel Road, Whitney Point, New York, on Tuesday, May 19, 2020, from 1:00 p.m. to 8:00 p.m., for the purpose of transacting of such business as is authorized by the Education Law.

NOTICE IS ALSO GIVEN that the proposed 2020-21 School Budget will be presented at the annual Budget Hearing to be held on Tuesday, May 5, 2020, at 7:00 p.m., High School Library, 10 Keibel Road, Whitney Point, NY.

NOTICE IS ALSO GIVEN that a copy of the statement of the amount of monies which will be required for the 2020-21 school year for school purposes may be obtained by any School District resident during the seven (7) days prior to the budget hearing, Tuesday, May 5, 2020 except Saturday or Sunday upon request, at any School District building and the School District offices between the hours of 7:45 a.m. and 3:45 p.m., at any public library or free associate library within the district, and on the School District's internet website. A copy of such statement may be obtained by any resident in the district at any School District building during the fourteen (14) days immediately prior to the Annual Meeting, May 19, 2020, and on the day of the Election except Saturdays, Sundays or holidays between the hours of 7:45 a.m. and 3:45 p.m.

NOTICE IS ALSO GIVEN that Absentee Ballots are available from the office of the District Clerk, by mail or in person. Mailed requests must be received seven (7) days before the vote at PO Box 249, Whitney Point, NY, 13862. Requests made in person, must be made at the District Office, 10 Keibel Road, Whitney Point, NY between 7:45 a.m. and 3:45 p.m., Monday through Friday and must be made no later than the day before the vote. A list of persons to whom absentee ballots have been issued will be available for inspection in the District Clerk's office during each of the five (5) days

preceding the vote, except Saturdays, Sundays or holidays, during regular office hours until the day of election.

NOTICE IS ALSO GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the School District Clerk between the hours of 7:45 a.m. and 3:45 p.m. not later than April 20, 2020 at the District Offices, High School Building, 10 Keibel Road, Whitney Point, NY 13862.

Candidates must be a citizen of the United States, eighteen (18) years of age, able to read and write, a legal resident of the School District one (1) year prior to the election, not an employee of the Whitney Point Central School District, and remain a qualified School District voter throughout the term of office.

The following vacancies are to be filled:

- (1) A three (3) year term ending June 30, 2023, presently held by Stephanie Champney
- (2) A three (3) year term ending June 30, 2023, presently held by Kathleen Driscoll
- (3) A three (3) year term ending June 30, 2023, presently held by Thomas Tasber
- (4) A one (1) year term ending June 30, 2021, presently held by Eddie Maslin

Each petition must be directed to the School District Clerk, be signed by at least twenty-five (25) qualified voters of the District, or by two percent (2%) of the number of voters who voted in the previous election, whichever is greater, shall state the residence of each signer, shall state the name and residence of each candidate and whether such candidates are nominated for full terms or for unexpired portions of such terms. The candidates receiving the largest number of votes shall be declared elected in accordance with Education Law (2018b). No person shall be nominated by petition for more than one specific office.

NOTICE IS ALSO GIVEN that another proposition on the ballot would authorize that the Board of Education of Whitney Point Central School District, located in the counties of Broome, Chenango, Cortland and Tioga, New York, is hereby authorized to purchase three (3) new 71 passenger diesel buses at a cost not to exceed (\$129,557.00) each for a total not to exceed (\$388,671.00), and one (1) new 5 passenger gas Dodge Durango (or equivalent) at a cost not to exceed (\$38,685.00), and to expend therefore not to exceed the estimated total cost of (\$427,356.00) including incidental expenses in connection therewith; and that such sum, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, the Board of Education is hereby authorized to issue bonds or other obligations of the School District in the aggregate principal amount of up to (\$427,356.00).

NOTICE IS FURTHER GIVEN that another proposition on the ballot would authorize the Board of Education of the Whitney Point Central School District to levy and collect an additional twenty two thousand dollars (\$22,000) in annual taxes, year after year, separate and apart from the annual school district budget, thereby authorizing a total annual tax in the amount of one hundred sixty two thousand dollars (\$162,000), of which ninety seven thousand dollars (\$97,000) shall be paid to the Mary Wilcox Memorial Library for the support and maintenance of the library and sixty-five thousand dollars (\$65,000) will be paid to the Lisle Free Library for the support and maintenance of the library; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Whitney Point Central School District.

PLEASE TAKE FURTHER NOTICE that any other propositions that are required to be included for vote at the Annual Meeting shall be submitted in writing by means of petition signed by at least twenty-five (25) qualified voters, or five percent (5%) of the number of voters of the District who voted in the previous annual election, whichever is greater, and shall state the residence of each

signer. Any proposition may be rejected by the Board of Education if the purpose of the proposition is not within the powers of the voters or where the expenditure of money is required by the proposition and such expenditures fail to include the necessary specific appropriation.
