#### A. WORK SESSION

Whitney Point Central School District Business Executive Zachary Woodard discussed the budget process and provided a general financial overview. Mr. Woodard shared a spreadsheet to show where the School District currently is financially, what our significant cost drivers are, and our limitations on revenue.

Mr. Woodard stated that due to the status of the pandemic, we are unsure what the next year will look like financially and that he would be surprised if there is an increase in Foundation Aid for the next school year.

Dr. Widdall stated that there are currently no contract raises being given at SUNY Cortland and asked if this is being considered for Whitney Point School District as an option to save money.

Mr. Woodard responded that there are employee contracts with contractual raises, so that has not been considered.

Mr. Tasber recalls a discussion about reimbursement rates being held flat and requested a refresher.

Mr. Woodard responded that last year one of the Governor's initiatives was to group all aid categories together and get rid of the reimbursement category and add a plan percentage. The Foundation Aid would include BOCES Aid and Building Aid. These would not be reimbursement based but would be capped at the percentage increase for that year. He is currently unsure if this will be proposed again.
