1. Ag in the Classroom Presentation

Sarah Atwood, Cornell Cooperative Extension Ag in the Classroom Educator, gave a presentation on Ag in the Classroom. Ms. Atwood stated the Ag in the Classroom Program teaches children about farming, planting food, where their food comes from and how to be sustainable. She stated the Ag in the Classroom Program is active in approximately 13 local school districts. She discussed several of the different Ag in the Classroom lessons taught throughout the year and explained how the lessons are often aligned with the seasons to increase relevance for the students.

Kathleen Driscoll commented that this is a fantastic program. She stated she was happy to see the school involved with a program that will build back farming and agriculture in our area. She stated it would be nice to renew interest in this area.

2. Tioughnioga Riverside Academy Academic Improvement Plan

Mrs. Chestnut presented the Tioughnioga Riverside Academy 2018-2021 Academic Improvement Plan. She reviewed the 2018-2021 Performance Measures. She stated in most areas they are exceeding the average growth of similar students in the measure. She stated some of the performance measures do not reflect accurate numbers as a result of students opting out of testing. She discussed i-Ready and how it helps students at their grade level and looks at growth.

Ms. Lamuraglia reviewed the overall improvement in attendance and proficiency. She stated absences at 10% or more are considered chronically absent. She discussed the targets and the mandated accountability areas and reviewed in detail the improved communication measures taken regarding the importance of good attendance.

Ms. Chestnut discussed refusal rates. She stated 80% of students participated in testing last year and 90% this year. She stated there is still work to do but feels they are making progress.

Ms. Chestnut explained in detail the 2018-2019 Shared Decision-making Team's improvement activities.

A discussion ensued about activities implemented to promote attendance.

7. RESOLUTION OF THE BOARD OF EDUCATION OF THE WHITNEY POINT CENTRAL SCHOOL DISTRICT REGARDING A STATE ENVIRONMENTAL QUALITY REVIEW ACT DETERMINATION FOR THE PROPOSED PROJECT

At the regular meeting of the Board of Education of the Whitney Point Central School District, Broome County, New York, held at the Whitney Point Senior High School Library, 10 Keibel Road, Whitney Point, New York at 7:00 p.m. on the 7th day of May, 2019.

WHEREAS, the Board of Education of the Whitney Point Central School District ("Board") is proposing to undertake a \$100,000 Capital Outlay Project, consisting of construction and renovations including incidentals and expenses relating to door hardware and associated work relating to the gymnasium air conditioning system at the Senior High School ("the Project"); and

WHEREAS, the Board wishes to fully comply with its obligations under the State Environmental Quality Review Act (SEQRA) and the regulations thereunder with respect to the proposed action; and

WHEREAS, the Board has carefully considered the nature and scope of the proposed action.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of the Whitney Point Central School District, Broome County, New York, as follows:

- Section 1. The proposed action involves renovations to the doors and the air conditioning system at the Senior High School.
- Section 2. The Board of Education hereby declares itself lead agency pursuant to SEQRA.
- Section 3. The review will be not be a coordinated review.
- Section 4. The proposed project represents the replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site within the meaning of 6 NYCRR 617.5(c)(2); and/or represents routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area within the meaning of 6 NYCRR 617.5(c)(11).
- Section 5. The proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and is therefore not subject to review under SEORA and the regulations thereunder.

Mr. Woodard stated these resolutions are required for the project. He stated the next resolution is Phase III of the referendum. He stated they could not do the gym air-conditioning with just 100,000.00. They proposed to use the remaining money authorized. \$100,000.00 can only be at one building. He explained they will also be using some of the money to purchase hardware needed for doors.

Stephanie Champney asked if the air conditioning will be completed by June.

Mr. Woodard stated no, but they are hoping for next June.

- Mr. Jeker asked if they were going to request a completion date.
- Mr. Woodard stated the project has a timeline.
- Mr. Jeker asked if there were any penalties.

Mr. Woodard stated no. He explained the State Education Department determines process and how it affects deadlines. He stated the district does have an option to request a 3rd party review that would expedite the process. He stated the State has an average 40-week review time and a third party would have approximately 15-week review time. He also stated a penalty may drive up the prices.

WHEREAS, the Board of Education of the Whitney Point Central School District ("Board") is proposing to undertake Phase III of the originally voter approved 2015 Capital Project Referendum in the amount \$13,038,022, consisting of the construction and renovations and associated work relating to the air conditioning system in the gymnasium at the Senior High School ("the Project"); and

WHEREAS, the Board wishes to fully comply with its obligations under the State Environmental Quality Review Act (SEQRA) and the regulations thereunder with respect to the proposed action; and

WHEREAS, the Board has carefully considered the nature and scope of the proposed action.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of the Whitney Point Central School District, Broome County, New York, as follows:

- Section 1. The proposed action involves replacement of the air conditioning system in half of the gymnasium at the Senior High School.

The proposed project represents the replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site within the meaning of 6 NYCRR 617.5(c)(2); and/or represents routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area within the meaning of 6 NYCRR 617.5(c)(11).
