MINUTES

Tuesday, May 6, 2014 7:00 p.m. High School Auditorium

The Public Budget Hearing was called to order at 7:04 p.m. by the Board President, Mrs. Sara Benscoter.

I. <u>Annual Meeting Chairperson</u>

It is appropriate to select a chairperson for this Annual Election and Budget Vote. This Chairperson will conduct the meeting, and will open and close the polls on Tuesday, May 20, 2014.

Ms. Follette recommended Cynthia Burchell be appointed Annual Meeting Chairperson.

Mrs. Benscoter turned the meeting over to the Chairperson.

II. Budget Review

The Chairperson introduced the Board Members and Ms. Follette, who reviewed the Proposed Budget for the 2014-2015 school year. Ms. Follette discussed the current goals of developing a reasonable tax levy within the applicable regulations, maintaining focus on education and building a sustainable budget. She presented the proposed 2014-2015 budget of \$33,171,129 and tax levy increase of 1.89%. Ms. Follette provided details around the budget increases and tax levy impact. She reviewed in detail how the taxes are calculated in the different townships. Ms. Follette explained the budget highlights. She stated this budget proposal allows the District to:

- Increase the Tax Levy by 1.89% (our maximum allowable tax levy was 2.89%)
- Reduce the reliance on fund balance and plan for the future
- Avoid staff reductions
- Introduce American Sign Language as a foreign language offering (or add additional half-time Spanish Teacher)
- Develop THREE new Summer Enrichment Programs (various grade levels)

- Create a new Special Education Classroom providing the ability to educate more of our students at Whitney Point CSD with the addition of one full-time special education teacher
- Sustain the modified 4:00 bus run that was reintroduced into our budget during the 2013-2014 school year with much success
- Participate in a Math Professional Development Collaboration
- Continue to offer high quality educational opportunities and remain in compliance with all educational mandates
- Continue responsible stewardship of our facilities

Ms. Follette stated voters will be voting on whether the Board of Education of the Whitney Point Central School District shall be authorized to appropriate for the budget the sum of \$33,171,129 for the 2014-2015 school year and levy the necessary tax therefore with a projected tax levy increase of 1.89%

Ms. Follette stated four Board of Education seats will be up for re-election. Ms. Follette stated Thomas Tasber, Kathleen Driscoll, Stephanie Champney will be on the ballot. Voters will also have the opportunity to provide up to four write-in candidates as well. Ms. Follette stated the candidates receiving the highest three vote totals will be elected to serve a three year term. The candidate with the fourth highest vote total will serve a two year term. All terms would commence on July 1, 2014.

Ms. Follette stated a second Proposition will be placed on the May 20th ballot seeking voter approval to establish a Capital Reserve Fund with the ultimate cap of this fund being \$7 million dollars over a ten-year period to address future construction projects, renovations and major repairs. She stated the creation of the fund requires voter approval. She explained using expenses from this reserve also require voter approval. Ms. Follette stated establishing a capital reserve fund allows the district to continue planning for the long-term facility needs of our district.

Ed Driscoll asked if the fund can be taken out of what taxes are being paid now.

Ms. Follette stated yes. She clarified it allows the District to use any excess money for capital projects opposed to raising taxes.

III. <u>Introduction of Candidates</u>

The Chairperson explained voting for candidates for the Board of Education, and introduced the candidates for the open Board of Education seats.

Stephanie Champney stated this was her 12th year with the Board of Education. She stated serving on the Board is a necessary job and believes the District has come a long way balancing the needs of the community, district and students.

Kathleen Driscoll stated this was her 8th year on the Board of Education. She stated she has been a District resident for 36 years. Ms. Driscoll stated her grand children attend the District and her children have gone through the District. She

stated she would like to continue to serve because of her love for the District and the progress that has been made.

Thomas Tasber stated he has been a Board of Education member for 6 years and that he got involved to understand more about the District. He stated he has learned something new each year on the Board of Education. He stated he enjoys being a Board Member and feels he has enough diversity in his life to allow him to have a good understanding of the District's operations and student needs.

IV. Suspension of the Hearing

The Board suspended the meeting at 7:45 until 1:00 p.m. on May 20, 2014, at which time the polls will be opened.
