K. SUPERINTENDENT'S UPDATE

• STEAM Summer Program – Ms. Follette stated the District is moving forward with the STEAM Summer Program. Ms. Sexton stated STEAM is a very hands-on and exciting program.

Sara Benscoter stated they are learning life skills.

Thomas Tasber asked if the program was for a targeted group of students.

Luann Kida explained the list came from the District and the criteria for the students on the list is outlined from the funding source.

Ms. Sexton commended Luann Kida for all her hard work putting the program together.

A discussion ensued regarding potential community work for the program.

Ms. Sexton stated there are two other summer programs in the Whitney Point School District this year. She explained the end of the 2nd, 3rd and 4th grade years show the biggest loss in ELA. She stated through BOCES Enrichment Program the District will be able to assist about 20 students per grade in this capacity.

Ms. Sexton stated the second summer program is collaboration between Chenango Forks, Chenango Valley and BOCES. She explained it is another STEAM program to create interest in technology, art and math. She stated the students will participate in creative projects and will be working together.

• Guidance Flood – Ms. Follette stated SERVEPRO did a very nice job. She stated there is a temporary office setup in the trailer with an aide to walk the students back and forth. Ms. Follette stated she requested a mold report and that the Riordan Group helped put the bids together. She explained she expects the contractors to take approximately three weeks to complete the work. She stated it could potentially be completed mid-summer.

Ms. Follette commended Mr. Woodard for leading the District with this project.
