Old Business

a. Phase II Update

Mrs. Hibbard and Mrs. Lindsley presented an update on the Phase II Renovation work. Mrs. Hibbard stated the Tioughnioga Riverside Academy library is now open and the music rooms will be open soon. Renovations continue in the auditorium. Mrs. Lindsley stated testing on the boiler system to investigate fumes has been completed. A plan of action will be in place next month.

Mr. Eddie Maslin gave an Energy Management Update. He stated the district's energy savings to date is \$979,980.00 or 21% after 86 months into the energy program. The program is designed to be ongoing with free support from Energy Education.

Provide all labor, material, and equipment to furnish the following site work:

- Demolish existing backstop at Rotary Field,
- Roll Rotary soccer field,
- Remove installed berm on Rotary baseball field,
- Box out and install pavement along CEA service road at drainage structures,
- Improve storm system at rear entrance of CEA/MP gym.

The Contract Sum will be changed by this Change Order in the amount of \$8,753.00.

Provide all labor, material, and equipment to furnish the following site work:

- Extend curb and concrete walks for MP gym to service drive,
- Regrade lawn near new sidewalk at CEA/Pool entrance,

- Stake out and ribbon perimeter of Rotary soccer field,
