2. CURRICULUM UPDATE: (10 minutes)

A group of teachers and administrators attended a follow-up conference on Growth Mindset sponsored by the Maine Department of Education. We learned strategies for fostering a growth mindset in our learners and ways to communicate with our parents and community about the importance of mindset and the work we are doing with our learners.

The RSU 12 Community Literacy Team met for the first time this school year and reviewed progress on the goals and action items identified by the team last year. The team, with funding made possible by the State's PreK Expansion Grant, made it possible to provide every incoming preschooler with a bag of books, a welcome letter, and a parent handout describing some literacy strategies and games that can be done at home. The team will continue to work to put little libraries in the district's towns where they may not yet exist and to foster a love of reading in our community for all ages.

Each school's leadership team and district level administration met to learn how to use a tool called Dirigo Star to streamline school improvement efforts, articulate clear building goals, and measure progress towards those goals. This work will continue throughout the year and will help inform district goals and strategic planning. The Maine Department of Education is making Dirigo Star available to school districts free of charge.

Discussion about being sure to make the literacy bags available to all RSU 12 students regardless of school of attendance. Consider tying the bags to the check for residency process and working with town offices for distribution. Think about the marketing possibilities of these bags and include information about RSU 12 schools.
