## MLUSD Staff Compact for 2020-21 - Updated 2-18-21

We are very excited to welcome our students back to school! We also want you to know that MLUSD takes the health and well-being of our students, teachers, and staff very seriously. We commit to partnering with you to do all we can to ensure a safe and productive year.

Please read the commitments below and initial each one as a symbol of your agreement to partner with us during this unprecedented time. We appreciate our staff and believe that **WE CAN COME BACK BETTER!**

- ☐ I commit to checking my health every morning before reporting to work.
- ☐ I commit to not reporting to work if:
  - ◆ I am experiencing any of the following COVID-19 symptoms, that are new to him/her and are not related to any ongoing condition that she/he previously or regularly experience (i.e. seasonal allergies, migraines, sore throat, chronic mild chest congestion, etc.): Diarrhea, Fever/Chills, Cough, Shortness of breath, Difficulty breathing, Fatigue, Congestion/Runny nose, Nausea/Vomiting, Muscle or body aches, Headache, New loss of taste/smell, sore throat.
  - ◆ **Staff members returning to work only after 24 hours symptom free without medication. Example: if I have called in sick with a stomach ache on Monday I will not be able to return Tuesday.**
  - ◆ Someone in my household or someone I have come in close contact with (within 6 feet for 15 minutes or more) **has tested positive for COVID-19.**
  - ◆ **Someone in my household is experiencing a recent loss of taste or smell and has not received a negative COVID-19 test.**
  - ◆ I have a temperature of 100.4 degrees or higher.
- ☐ I commit to giving my supervisor as much advance notice of an absence as possible.
- ☐ I commit to leaving work if I become ill during the day.
- ☐ **I commit to wearing a face covering unless medically exempt.**
- ☐ I commit to encourage students on District campuses to wear face coverings, unless medically exempt, and practice social distancing.
- ☐ I commit to maintaining social distancing to the extent practical while on the school campus.
- ☐ I commit to following all the District's reopening plans including but not limited to: (1) Worksite Plan, (2) Distance Learning Plan, (3) Blended Learning Plan, (4) District Injury Illness Prevention Plan. (see MLUSD Staff Resources - all listed on MLUSD intranet).
