MLUSD Parent Compact for 2020-21 - Updated 2-19-2021

We are very excited to welcome our students and families back to school! We also want you to know that MLUSD takes the health and well-being of our students, teachers, and staff very seriously. We commit to partnering with you to do all we can to ensure a safe and productive year for our students.

Please read the commitments below and initial each one as a symbol of your agreement to partner with us during this unprecedented time. We appreciate our families and believe that **WE CAN COME BACK BETTER!**

- → I commit to checking my child's health every morning before sending him/her to school using the "Symptom Screening Prior to Entry" form attached, provided by the CDC.
- → I commit to not sending my child to school if:
 - My child is experiencing any of the following COVID-19 symptoms, that are new to him/her and are not related to any ongoing condition that she/he previously or regularly experience (i.e. seasonal allergies, migraines, sore throat, chronic mild chest congestion, etc.): Diarrhea, Fever/Chills, Cough, Shortness of breath, Difficulty breathing, Fatigue, Congestion/Runny nose, Nausea/Vomiting, Muscle or body aches, Headache, New loss of taste/smell, sore throat.
 - Students returning to school only after 24 hours symptom free without medication. Example: if they're called in sick with a stomach ache on Monday they will not be able to return Tuesday.
 - ◆ Someone in my child's household or someone my child has come in close contact with (within 6 feet for 15 minutes or more) has tested positive for COVID-19.
 - Someone in my child's household is experiencing a recent loss of taste or smell and has not received a negative COVID-19 test.
 - ♦ My child has a temperature of 100.4 degrees or higher.
- → I commit to being available to come pick up my child immediately if they are ill or present COVID related symptoms at school.
- → I understand that failure of my child to comply with the mask requirement will result in the student being sent home
- → I commit to wearing a face covering and maintaining social distancing if I need to access the school office or campus.
- → I commit to send my child with a water bottle each day, due to the closure of school drinking fountains. If we do not have one, we may contact our school office.
- → I commit to ensuring that my child leaves personal toys, sports equipment, etc. at home.
- → I commit to encouraging my child to refrain from sharing snacks and supplies.
- → I commit to following the District's reopening plans.
- → Due to COVID, the District has provided each student with a Chromebook and charger. I commit to making sure my child takes care of it, brings it back and forth to school each day if required by the teacher, and keeps it charged.
- → If my child rides the bus, I commit to promote social distancing at the bus stop if I can be there.
