- We did receive a check for $\mathbf{\$ 2 9 3 1 . 0 0}$ for the recycled technology equipment from this summer.
- Dunlap Withdrawal from SEAPCO - As was mentioned previously, Dunlap has formally requested to withdrawal from SEAPCO. At next month's meeting, the Board will be asked to approve a resolution granting that request.
- We are expecting an increase of $1.7 \%$ in our EAV for 2021.
- I want to thank Mr. Bentley for the smooth transition of the Athletic Director position. I am still getting up to speed. Congratulations to our baseball and softball teams for fine seasons. Cross Country is still competing and girls' basketball starts with games tonight.
- Athletic passes for LCHS and LW events have been distributed to Board Members.
- Nicole Bill has submitted her resignation as volleyball coach. We are very grateful for her years of service to LW .
- Gym Project Update -
- Wall pads have been installed but are royal blue instead of gray. We will have them rescreened this summer per H2I.
- Our architect is preparing a punch list for substantial completion.
- Our staff is in full compliance of the executive order for mandated vaccines and/or testing requirements. We are very fortunate that our staff has done what is expected of them to keep our school safe.
