President Monica Walker called the Board Meeting to order at 6:00 pm with a quorum established.

Director James Fowler made the motion to approve the agenda. Seconded by Director Jeromie Allen. Motion carried 6-0.

Director Tara Adkins made the motion to approve the consent agenda (approval of the minutes, authorization of the payment of bills {Director Adkins}) Seconded by Director James Fowler. Motion carried 6-0.

Old Business:

Director James Fowler made the motion to accept the Mann's Lawn and Landscaping bid for the total amount of \$8,432.65 for the landscaping project that was discussed at the September board meeting. The project was put out to bid and the bids received are in the board packet for review. The anticipated completion date for the project is April 2022. Seconded by Director Victor Orta. Board approval is required for the district to be recognized and chartered through the Missouri Department of Education. Seconded by Director Victor Orta. Motion carried 6-0.

Director Jeromie Allen made the motion to hire Sara Beth Michael for our open Winter Cheer Coach position. Seconded by Director Tara Adkins. Motion carried 6-0.

Director Jeromie Allen made the motion to maintain our current district paid portion toward our monthly individual insurance premium at \$525.00. For the upcoming year, we were able to negotiate a 4.9% increase in our insurance renewal rates. A complete list of plans/rates is provided in the board packet. Seconded by Director Victor Orta. Motion carried 6-0.

Director Tara Adkins made the motion to add Caleb Brashears to the 2021-2022 substitute teacher list. Seconded by Director Jeromie Allen. Motion carried 6-0.
