#### **BASIC FUNCTION:**

Counsels individuals and provides educational and social skill guidance services for students who are academically and/or behaviorally at risk; under the direction of the site principals.

### **ESSENTIAL FUNCTIONS AND RESPONSIBILITIES:**

- Provide support services and supervises students in the areas of academic programs, team teaching, registration, course planning, school rules and other matters.
- Schedule and hold individual conferences with students and their families to explain academic records, coursework, and progress needed for satisfactory completion of school.
- Identify students who are at risk for not promoting and provides support services that will assist students in meeting standards.
- Develop a list and plan of coursework and interventions necessary to assist each pupil in grade 7 who is at risk in ELA and/or mathematics as indicated on grade 6 standardized assessments, report cards, attendance and/or behavior. Assists these students in meeting the expectations for successful promotion from grade 8.
- Assist students who are not achieving grade level expectations in making smooth transitions between elementary, middle and high school.
- Maintain records of student plans and student meetings for success in cum files/student information system.
- Apprise students and their families of consequences for not passing courses and communicates plans for at risk students.
- Maintain records of student data necessary for completion of annual report to state on success rate of students assisted by this counseling program.
- Assist students, consults with teachers to promote cooperative efforts and to serve as a referral agent.
- Consult with others on curriculum development, testing, records, placement, grouping, promotion, student evaluation, and screening of students.
- Interpret the functions of the counselor to students, teachers, parents and the general public.
- Attend IEP and SST meetings for students receiving counseling services.
- Provide and/or refer students and parents for psychological counseling.
- Provide parent education to support School Counseling efforts.

• Work collaboratively with the School Psychologist and Principal in the school and districtwide development and implementation of Positive Behavioral Interventions and Supports (PBIS) and Behavior Intervention Plans (BIP) for individual students.
