- 8. Participate in 504 and Individual Education Plan (IEP) meetings and provide accommodations for students as outlined in documentation.
- 9. Participate in all state and District assessments.
- 10. Participate in professional learning activities provided by the District and school sites, either in person or virtually.

11. Be available to learning coaches and students for support and communication and respond to requests for support within 48 hours during the contractual work week.
