

**INTERDISTRICT AGREEMENT (IA)
FOR COOPERATIVE EDUCATIONAL SERVICES
2015-2016 SCHOOL YEAR**

This Agreement is hereby entered into by and between the **Tri-Tech Skills Center, Kennewick School District No. 17**, Benton County, Washington, which is hereinafter referred to as the "**SERVING DISTRICT**," and **Prosser School District No 116** Benton County Washington hereinafter referred to as the "**PARTICIPATING DISTRICT**".

The purpose of this Agreement is to utilize interdistrict cooperation, authorized by RCW 28A.335.169, RCW 28A.225.250, and Chapter 392-135 WAC, to provide educational programs not otherwise available and to avoid duplications of specialized programs and facilities. These objectives will be achieved by enrollment and attendance in Career and Technical Education (CTE) and Learning Opportunity Center (LOC) academic programs at the Tri-Tech Skills Center.


This agreement gives Tri-Tech Skills Center permission to access student address information from the data resource management center of the **PARTICIPATING DISTRICT** to be used for mailing newsletters, program brochures, summer school information, and student information.

For the purpose of this agreement, it is understood that students attending the **PARTICIPATING DISTRICT** and the **SERVING DISTRICT** shall be funded for all classes up to 1.6 full time equivalent as determined by the Office of the Superintendent of Public Instruction per the 2012-2013 Enrollment Handbook with no more than 1.0 FTE reported by either the **PARTICIPATING DISTRICT** or the **SERVING DISTRICT**. The **SERVING DISTRICT** shall claim up to a .2 Skills Center FTE for each period that a student attends a Tri-Tech Skills Center CTE program (3 periods = .6 FTE) and up to a .4 basic education FTE for Learning Opportunity Center (LOC) academic classes. Enrollment in the CTE course and the academic course is made at the request of the student and the **PARTICIPATING DISTRICT**.

The **PARTICIPATING DISTRICT** shall be responsible for:

- providing ancillary services for the student
- state testing
- fees as identified in the Tri-Tech Skills Center Cooperative Joint Operational Agreement, i.e. SPED Liaison Fee (based on % of SPED population) and Tri-Tech Maintenance Fund of \$150 per enrolled student both billed in March, 2016

This Agreement is for the 2015-2016 school year must be signed by the appropriate officials prior to confirmed enrollment of the student.

**Yearly Renewal Agreement
for Interdistrict Cooperative Educational Services
for the 2015-16 School Year**

YV-TECH Skills Center claims .6 FTE per full time equivalent student scheduled on a 3 period basis. The skills center will claim .2 fte for any A.L.E. (formerly VEP) or contract class up to 1.0 fte. The Washington State Legislature passed bill 2SSB 5790 for Skills Centers during the 2007 legislative session. This bill allows high schools and the skills center to claim students that are attending skills center programs up to a combined 1.6 fte. Neither the high school nor the skills center can individually claim more than 1.0 fte. **OSPI rules and regulations are posted on the OSPI website at www.k12.wa.us/safs.** The WAC for full time equivalency is WAC 39-121-22.

I hereby approve YV-TECH to claim up to a 1.0 fte when our district requests additional educational contract services beyond the regular program offerings (.6) of YV-TECH.
