DECEMBER BOARD REORGANIZATION MEETING

1. Call to Order.

2. Roll Call.

3. Meeting is convened by Designee.

Designee will act as temporary President and will swear in the newly elected members as provided in Section 321.

Section 321. Compensation; Oath of Office.

All persons elected or appointed as school directors shall serve without pay except as hereinafter provided. Before entering upon the duties of their office each shall take and subscribe to the following oath or affirmation, which may be administered by any one qualified to administer an oath, or as hereinafter provided:

"I do solemnly swear (or affirm) that I will support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity."

5. Reorganization of School Board.

Section 404 of the School Code states, "In each school district of the second, third and fourth class, the school directors shall effect a permanent organization by electing, during the first week of December, from their members, a president and vice-president, each to serve for one year."

8. Treasurer of the Board.

Treasurer of the Board is elected for a one-year term beginning July 1st each year. Mr. William Ross is currently serving as Treasurer. (Informational Item)

Currently, the Board meets for a Work Session on the Monday one week prior to each regular business session at 6:30 PM in the Board Conference Room. The regular Board Meeting is held the 3rd Tuesday of each month beginning at 6:30 PM.

Joint Operating Committee members serve three-year terms. Mr. Bullington and Mr. Clark are currently serving 2019 through to the end of 2021. Mr. Cessna, Mr. Oldham, and Mr. Flaaen are currently serving until the end of 2023. We will need to elect one member to complete Mr. Flaaen's term (until the end of 2023) and two members to a new three-year term (2022 through to the end 2024).
