Cassadaga Valley Central Schools Test Out of Quarantine Option and Procedure

In accordance with CDC guidance, a student or staff member in quarantine as a close contact to someone with confirmed COVID-19-is now allowed to end quarantine after day 7 (i.e., day 8) after receiving a negative test result, as long as the test occurs on day 5 or later of the quarantine period.

- Such individuals who are released from quarantine early are strongly encouraged to continue to monitor for symptoms and to wear a mask around others for 14 days following their last day of exposure to the person with COVID-19.
- The **Affirmation of Quarantine** must be submitted to the District to affirm a staff or student's quarantine period.
- Chautauqua County residents do NOT need to call the Health Department to be released from quarantine.
- Those testing out of quarantine early will need to submit **a negative test result** to the District prior to returning to school or work

- <u>AFFIRMATION OF QUARANTINE</u> This form must be used for Quarantine Release and for NY Paid Family Leave COVID-19 claims as if it was an individual Order for Quarantine issued by the Chautauqua County Public Health Director.

STEPS to Follow:

- 1. Have a COVID Test on day 5 or later of the quarantine period
- 2. Download and complete the AFFIRMATION OF QUARANTINE Document
- 3. Download and follow the <u>CCHD Option for Release from Quarantine After Day 7</u>
 <u>Requirements</u>
- 4. Submit negative COVID test results and Affirmation of Quarantine Document to the School Nurse (student) or Superintendent's Office (staff)
