Discussions concerning ESSER III funds took place this spring during the time of the LCAP development. The Federal and State funds that PUSD will be receiving over the next three years were included in the development of the LCAP and are being reflected in this plan.

Stakeholders were engaged in multiple ways during the school year. PUSD has the following standing committees in which input is requested and discussion had each time they meet: DELAC, HEAC, LCAP/Budget, Superintendents Advisory Committee, Student Advisory Council, Site Council and SPED. These committees are made up of Staff Members, Administration, Parents and Community Members. LCAP is a specific item on each of these agendas.

In addition to the District Standing Committees LCAP along with District Goals and Objectives are discussed regularly at School Board Meetings, Admin Team Meetings and Site Meetings on a monthly basis. Also quarterly there are ELD Team meetings, SPED Team Meetings and Counselor Team Meetings that are held. The Superintendent also meets regularly with Executive Leadership Team of both Bargaining Units, specific discussion concerning the LCAP is held at least twice per year. Parents are surveyed each year in conjunction with the writing of the LCAP. There is a survey that goes out to all parents and an additional survey that goes out to our EL families.

Meetings are held at the County level to discuss the needs for both Special Education and Foster Youth. This meeting took place on April 21st this year.

Our LEA reviewed our past interactions with community partners and found that tribes, civil rights organizations and advocates of specific student groups are not present or served by our LEA.

The academic needs of the students were on the forefront of stakeholders minds as the plan was being developed. Also the Social Emotional needs of students were seen as an important aspect of the education process. We addressed the social emotional needs and the safe opening of schools with other one time State and Federal funds received while a heavy focus on the academic needs of students were addressed with ESSER III funds. Summer School, Small group instruction and lower class sizes were addresses with the ESSER II funds.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,

  - Tracking student attendance and improving student engagement in distance education;
