Request to Purchase a Utility Van for Technology Center

With the recent rapid acquisition and deployment of technological hardware across all of our schools, the need to deliver new equipment and to transport equipment for replacement and repairs has drastically increased. Our Tech Center Chief Technician (Louie Penning), and Technology Department Director (Angie Arnold), have requested the purchase of a basic panel utility van so personal vehicles will not have to be used for this purpose. It is estimated that the vehicle purchase can be made for under \$40K. ESSER III Grant funds can be used because this purchase would fall within the category of technology enhancement and support as per the grant guidelines.
