SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application - Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application - Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The District held a number of developmental work sessions with Administrators, Dept. Heads, and certain employees designed to develop the overall Budget plan regarding the use of the ARP Act funds, in a similar format to the process used with the CARES Act and CRRSA funds. The Plan development was reviewed and discussed at several Board of Education Meetings. Additionally, the District utilized a survey tool to solicit the opinions of District residents. The community survey results were included in the evaluation and determination of the final Budget. The ARP Act funding will continue to be addressed at BOE Meetings and Budget Development workshops over the term of the Grant.

The District will continue to implement and follow all CDC, NYSDOH, and Clinton County DOH guidelines and guidance regarding the operation of in-person learning. The associated Budget Plan for the ARP-ESSER funds does include additional nursing positions to assist in the remote learning process in areas such as infection rate monitoring, contact tracing, vaccination status tracking, quarantining and isolation orders, etc. that are a necessary part of the process to maintain a safe in-person program.

The District will utilize annual standardized test results, various assessment tools, mental health evaluations, discipline and counseling referrals, and attendance data; all of which will be compared to Pre-COVID results to help identify student needs. In subsequent years of the multi-year Plan, rupdated test and assessment results will be compared and analyzed to the base year results to help determine the effectiveness of the various interventions applied. The majority of the interventions are related to extended learning opportunities, both through Summer School programming as well as after-school instructional opportunities being added. Additionally the funding will be used to support the cost of additional Teacher Aide/Student Aide(s) to allow for small group instruction which is key to many intervention models.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The District will utilize the required 20% reserve of its ARP-ESSER LEA Base 90% Allocation to fund a portion of Summer School Programming, After School Instructional Programming, and additional Teacher Aide/Student Aide position(s) to help implement suggested and proposed interventions, many of which function in small group settings that require the additional instructional support staff. The Summer School and After School Programs would largely be in FY 23-24 and Summer of 2024, due to the fact that the District is utilizing a portion of its CRRSA funding to cover similar programs in FY 21-22 and FY 22-23.

The District will utilize the 20% LEA level reserve for learning loss (\$315,885) to cover salary (87,500) and benefits (130,750) of five (5) full-time Teacher Aide/Student Aide(s) in FY 21/22. Also the funds will be used to cover a portion of Summer School costs in J/A 2024. The total for this program, utilizing the 20% reserve is \$97,635; Salaries (78,108) and Benefits (19,527).

The Aide(s) will help implement and carryout various grade level specific High Dosage Tutoring Interventions through push-in to the classroom and working with targeted, small groups of students identified as in need of Academic support.

The Summer School Program will extend the educational cycle by an additional (20) days in J/A, targeted for students identified as in need of Academic support.

The Districts plans to use the remaining 80% of its ARP-ESSER LEA Base 90% Allocation in a variety of ways (detailed in the attached Budget) to support the continued operations of in-person learning, strengthen our oversight and response to SEL/Mental Health needs of our student body, provide resources to help offer instruction to students temporarily quarantined or isolated due to pandemic related health issues (thereby allowing us to maintain the current instructional system's personnel and resources for the remaining in-person population), and offer various alternative instructional/extra-curricular activities that in most cases will take place in an after school setting, thus extending the learning day. The remaining 80% of the ARP ESSER (LEA level) funding will be used to:

- 1) Salary (180,000) and benefits (90,000) of additional School Psychologist covering the entire funding period, to provide additional support/response to student SEL/Mental Health issues.
- 2) Salary (220,000) and benefits (113,445) of Educational Technology Coordinator covering the entire funding period, to provide additional support to both in-school and remote learning platforms for students not able to participate in in-school learning as well as to faculty who need to provide the remote instruction.
- 3) Salaries (195,000) and benefits (205,000) of (2) LPN positions covering the entire funding period, to provide necessary support to allow for inperson learning with mandated COVID protocols in place.
- 4) Various supplies/materials & purchased services to increase the educational and extracurricular opportunities of students through programs such as STEM, drone technology, E-Sports, Interscholastic Bowling, and Drama Club.
- 5) Purchased Services (\$70,594) to cover the costs of a Board Certified Behavioral Analyst over the entire funding period, to provide additional support to the instructional process working with students who are demonstrating behavioral issues due to the negative effects of the pandemic. Additionally, under the 20% LEA level Reserve for Learning Loss, the District will carryout a Summer School Program in J&A 2024. This will include a portion of salaries and benefits for Teachers, Aides, Admin., RN(s), Bus Drivers and Bus Monitors (if needed). The J&A 2024 Summer Program costs are being split between the ARP State Level Reserves (\$30,000) and the ARP 20% LEA Level Reserve for Learning Loss (\$97,635).
- 7. The District will continue to periodically test and evaluate the student body's educational and mental health status and compare all new results to prior testing points as well as baseline data (See also Q.#4 response). Based on the District's relatively high level of students with disabilities and students from low-income families, these segments of the overall student body will continue to be highly scrutinized and evaluated to determine the effectiveness of interventions in place and for the possible need to change or enhance the currently selected interventions.

The District has a fairly high percentage of students from low-income families and students with disabilities. Additionally we serve a much lower percentage of students who are experiencing homelessness, are in a Foster Care setting, or are seasonal migrant students. Due to the high number of students in the first two categories, as is common in rural, high needs schools such as ours, a significant portion of both our Regular Budget as well as the ARP ESSER Budget is focused on students in these subgroups.
