Trustee Cusick asked about EP#2 and EP#6. Mr. Burke explained that the county monitors all aspects of the school district and that the school district has a safety plan with the police, protocols were added designating St. Therese as CHS "annex". Trustee Cummings asked about DRTRS. Ms. Delasandro explained that it documents the cost of all transported students. Trustee Klein asked about Laura Bishop and her experience. Mr. Burke explained that Laura Bishop is a Public Relations Firm with expertise in communicating to the public and assisting with the website. Vice President Moldt asked about Laura Bishop's scope of work for the district. Mr. Burke replied that meetings are this week to establish scope of work. President Villani added that most school districts subcontract their websites. Trustee Gorfin asked about the long term plans for the website. Mr. Burke replied that a position to manage the website will be created and someone will be hired or a stipend position will be created. Mr. Burke replied to Trustee Gorfin that the safety/fire plan will be updated at St. Therese upon a full day student schedule. President Villani publicly thanked Broadwaters for donations. Trustee Gorfin asked how Laura Bishop was being paid. Ms. Delasandro replied from the operating budget, reimbursed by FEMA. Trustee Gorfin asked if the total number of students attending the Bergen Academies/Technical schools was increasing. Mr. Burke replied yes, it is trending up. Trustee Klein stated that at county meetings, there is push back for money back from Bergen Academies. Trustee Gorfin asked how the Northern Valley Regional program was doing. Mr. Burke replied that it was doing well, but in talking to the NVRHS superintendent, the key was having the space.

#### **BOARD PRESIDENT'S REPORT**

President Villani stated that the live feed of the Boys Soccer game was lost and that she hoped they won. She attended the Town Council Meeting with Trustee Cusick. Cresskill residents are having issues with flooding and were told to contact their legislators. President Villani appreciates the current letter writing campaign as it seems no one realizes that the school flooding is an emergency except for the people of Cresskill. She has asked the Mayor to work together. President Villani's house was flooded during Ida also. She stated that we need to work together but that the town council and the Board of Education are still two separate entities. She congratulated Barbara Costa, Daniel Ricardo and Sally Cummings on their elections to the board, based on the unofficial results.

#### SUPERINTENDENT'S REPORT

Mr. Burke stated that he has some answers to many of the questions from the last meeting. Regarding the Referendum, 75% of the funding will be received back from the State. A series of events need to occur before the district gets any money. Mr. Burke will be meeting with Mr. Pascrell tomorrow and will ask what we can do to bypass the current purchasing laws. The district received a donation of twelve 75" televisions from LG. LG has another donation that he will find out about tomorrow. The 11th and 12th graders had the first half day of classes in person at St. Therese today. What the district needs now is the actual money to make purchases. Please continue contacting our legislators. The school

still has no boilers more than two months after the flood. Mr. Burke expressed gratitude to the staff for all of their efforts. He especially thanked John Massaro and Lemma Taha for getting the scheduling working at St. Therese. He stressed the need for Cresskill residents to push their elected officials. Mr. Burke was very happy to have gotten into St. Therese today. Mr. Burke explained we had a walkthrough of the middle/high school building last Friday with the town officials. They commented that we no longer "have a school since it was destroyed". Mr. Burke provided the names of attendees at the Friday meeting; it seems hard to achieve based on the building's current state, but he is still evaluating opening one wing of the high school for in person attendance.

#### **PUBLIC COMMENT - ANY SUBJECT**

Citizens may address the Board of Education on any item not listed on the agenda. Citizens will give their names and addresses when recognized to speak. A time limit of three minutes per person and a total of 30 minutes for all communications are allowed. Large groups are urged to select someone to represent them.

Ms. Park was at the council meeting and asked about the use of the Recreation Center. Mr. Burke replied that he will be having a joint use meeting. Mr. Spelbrink, Mr. Burke and Ms. Delasandro explained financing options - short term versus long term versus donations. A Resident asked about plans for a second location. Mr. Burke replied that they are looking at a newer building that is more updated than St. Therese. He hopes to have the second location available as of December 1. Temple Emanu-el is being considered plus a 3rd location. A Resident asked why temporary heating was needed at the high school. Ms. Delasandro replied that there is water in the pipes and we can't risk frozen pipes. Mr. Barkan stated that CHS may not be open until spring. What is holding up Temple Emanu-el and getting into the high school wing? Temple Emanu-el has never done anything like this before, Mr. Burke is meeting with them tomorrow. Ms. Delasandro explained what's needed to open the wing. Mr. Burke was not comfortable giving a date for the possible opening of a wing of the high school. Mr. Pierce asked about transportation to Temple Emanu-el. Ms. Barrs called the county DOE who said nothing could be done at the county level, only the state can do something. Questions were asked about the referendum to which Ms. Delasandro replied that nothing was finalized vet. Vice President Moldt commented about the supply chain issues causing delays. A Resident asked if there was any chance that the school would not open in September and if temporary locations be available. Mr. Burke believed that the temporary locations would still be available in September. Trustee Odabashian asked if we rebuild, but only have \$2 million in insurance and stay on wetlands, what then? Mr. Burke stated the goal is to safeguard the most important rooms like the boiler room. A Resident asked if the boilers are donated, do we need FEMA? A Resident asked if we can harness the power of the brook to produce bitcoin. Vice President Moldt replied that the town is not allowed in the brook, the 7 towns that the brook runs through need to be coordinated. Mr. Ricardo asked about enrollment loss. Mr. Burke replied about 50 students but he will get the figure. A Resident asked if the school can get a credit card, Ms. Delasandro replied no, not allowed, but that short term notes are essentially credit. Trustee Klein asked if NJSBA can be used as a lobbying group. She appreciates the letter writing campaign but needs a unified message in the letter. Trustee Gorfin asked John Massaro, Principal, to speak. Mr. Massaro thanked everyone and stated that today was a triumph in getting the children back in person. Many plans had been put together since September. He thanked Lemma Taha. This is a unique school spanning 7 grades. When the internet is complete, hybrid learning will start. Mr. Massaro reminded the residents that drop off needs to be done on the northbound side of Jefferson Avenue only. Mr. Massaro participated in a question/answer period with the residents. Trustee Gorfin asked how virtual and asynchronous learning is progressing and what is being done for the students' mental health. Mr. Massaro replied that once the internet is fully operational, asynchronous classes will not be necessary. The Guidance department is at the town library, we need to keep working on the mental health program.

**WHEREAS**, The Board of Education of the Borough of Cresskill in the County of Bergen, New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed thereby), seeks to submit to the voters school facilities projects (the "Projects");

WHEREAS, the School District will seek Debt Service Aid with respect to the Projects; and

**WHEREAS**, the Board now seeks to take the initial steps in order to proceed with the planning and authorization of: (i) the Projects; and (ii) a School District special election at which time a bond referendum authorizing the Projects shall be presented to the voters of the School District.

**NOW, THEREFORE, BE IT RESOLVED** BY THE BOARD OF EDUCATION OF THE BOROUGH OF CRESSKILL IN THE COUNTY OF BERGEN, NEW JERSEY, as follows:

Section 1. In accordance with the requirements of Section 6A:26-5.1 through 6A:26-5.3 of the New Jersey Administrative Code, the Board hereby authorizes and/or ratifies the preparation of Schematic Plans and Educational Specifications, if required, by DiCara & Rubino ("DICARA") in connection with the Projects and the Board further authorizes and directs DICARA to submit the same to the New Jersey Department of Education and to the Bergen County Superintendent of Schools for review and approval. The Board further authorizes and directs the submission of the Schematic Plans to the planning board for its review, to the extent required by law.

Section 2. In accordance with the requirements of Section 6A:26-2.3 of the New Jersey Administrative Code, the Board hereby ratifies any amendments to the Long Range Facilities Plan, as necessary, to reflect the Projects and approves the submission of any such amendment to the New Jersey Department of Education.

Section 3. In accordance with the requirements of Section 6A:26-3.2 of the New Jersey Administrative Code, the Board hereby authorizes and/or ratifies the submission of the Projects Applications and its decision seeking debt service aid for the Projects.

Section 4. With respect to the Projects, the Board hereby authorizes and directs the Board President, the Superintendent and the Business Administrator/Board Secretary, as applicable, to execute the schematic plans and educational specifications, the amendment to the Long Range Facilities Plan, the Projects cost estimate sheets and all related Projects documents allowing submission of same to the New Jersey Department of Education.

Section 5. The Board hereby authorizes and directs the Board President, the Superintendent, the Business Administrator/Board Secretary, DICARA, and Wilentz, Goldman & Spitzer, P.A., as Bond Counsel, as applicable, to take all action required to preserve the opportunity to present the Projects to the voters via a bond referendum at School District special election to be held on January 25, 2022 or such other date as may be available to the Board.

Section 6. This resolution shall take effect immediately.

Resolved, that the Board of Education, upon the recommendation of the Superintendent, approve Di Cara | Rubino Architects, Architect of Record, for Professional Services for pre-and post-referendum services for the Cresskill Board of Education to address emergent repairs and renovations at Cresskill Middle / High School (D|R Project #3936) in the amount of \$10,000 for pre-referendum services and a percentage of total project costs for post-referendum services, plus reimbursable costs.
- **11. Resolved,** that the Board of Education, upon the recommendation of the Superintendent, approve and submit to the County Department of Education the Health and Safety Evaluation of School Buildings Checklists for the Cresskill School District.
