#### **BOARD PRESIDENT'S REPORT**

President Villani was glad to see the 9<sup>th</sup> and 10<sup>th</sup> graders at St. Therese. Over the last two weeks she has called the Governor, Senators, and Congressmen from New Jersey. The only one to call her back was Holly Schepisi. She is waiting on a meeting with the Governor. She wished everyone a Happy Thanksgiving and to enjoy time with family.

## SUPERINTENDENT'S REPORT

Mr. Burke has a meeting with Representative Pascrell next week. Governor Murphy's Chief of Staff called Mr. Burke with various options for funding. Mr. Burke contacted the Executive Director of the Bergen County Improvement Authority. Money is available, but it is a 4 to 6 month application process. Mr. Burke discussed the January 25, 2022 Referendum stating that Purchase Orders could be written 20 days later. Temple Emanu-el is still being considered. However, there are internet issues, the space is not large, and lunch will need to be Kosher. Mr. Burke will be visiting additional alternative locations tomorrow. He stated that the gym at the high school is close to being opened.

## **PUBLIC COMMENT - ANY SUBJECT**

Citizens may address the Board of Education on any item not listed on the agenda. Citizens will give their names and addresses when recognized to speak. A time limit of three minutes per person and a total of 30 minutes for all communications are allowed. Large groups are urged to select someone to represent them.

A Resident asked about shared services with other districts/towns. A Resident stated that he is a lawyer and that we need an emergency meeting of the town to pass bonds. There should be a shared Borough/Board of Education meeting tomorrow. Mr. Burke replied that there is no tension between the town and the BOE. Everyone in the town is looking for the best solution. A resident asked what is stopping us from issuing emergency bonds. He spoke to a Congressman who stated he is waiting for the BOE to "make the move." A Resident stated that getting the main building back up should be more important than finding alternate locations. President Villani stated that we can only get money through a referendum. The State sets the dates and January was the first available to us. President Villani went to the last 2 mayor and council meetings. This is a town issue and there were nowhere as many people at the council meetings as there are here tonight. The BOE is all volunteer. The Board continues to work collaboratively. Mr. Burke stated that one of the temporary heaters at the high school

caught fire on Friday. He states that we are going to continue to fight. A Resident asked where are the experts, what is EPIC doing for us? Mr. Burke replied that EPIC has been working well with the architect. A Resident asked about legal issues. Is Temple Emanu-El still being considered? Mr. Burke replied yes, but there are obstacles. A Resident who had been at the council meeting stated that the Governor was reaching out to schedule a meeting. Mr. Burke replied that no meeting had been schedule. The Resident stated to the audience that we need to attend the council meetings. A Resident stated that the Mayor will not attend BOE meetings. Some parents met with Senator Cory Booker's office who said there are Federal funds available. Mr. Spelbrink stated that the governor's office said that they were here from Day One, actively looking for alternative space; the First Lady made Cresskill a priority. But Cresskill never made noise or asked for anything. We need to protest in Trenton. A Resident asked what the public relations consultant is doing. Mr. Burke replied that her main focus is the referendum and improving the website. Ms. Fischer stated that she feels like the children are being homeschooled, morale is low, teacher absences are out of control, so many posted assignments, all clubs are zoomed, and 9th and 10<sup>th</sup> graders never got their class trips. Ms. Shick commented that Mr. Burke may be hurting us in the news by being so positive. Ms. Shick stated Mr. Burke needs to be angrier in news interviews. A resident asked if we can join another town's high school and become a regional district. A Resident was concerned with supply back orders in reaching timelines set out for construction. A Resident thanked Mr. Burke for his hard work. When September 2022 arrives and we are in the same position, then what? This Resident moved here for the schools. Mr. Burke replied that he has dedicated 24/7 to opening the high school building as well as to finding alternative locations. He has no indication that it is not possible. President Villani asked for a moment of silence to remember a Dumont child who passed away at a basketball game.

## **COOPERATIVE SPORTS PROGRAM AGREEMENT**

This Agreement is being entered into, effective November 22, 2021, by and between the Tenafly Board of Education (hereinafter "Tenafly") and the Cresskill Board of Education (hereinafter "Cresskill");

WHEREAS, the Tenafly Board of Education has an Ice Hockey program that would allow for additional student players; and

WHEREAS, the Cresskill Board of Education has too few students interested in Ice Hockey to field a full team; and

WHEREAS, the Tenafly Board of Education and the Cresskill Board of Education wish to continue a Cooperative Sports Program for Ice Hockey.

Tenafly and Cresskill agree to the following:

- 1. Tenafly and Cresskill (hereinafter collectively referred to as "parties") shall submit a Program Application for Cooperative Sports to the New Jersey State Interscholastic Athletic Association (hereinafter "NJSIAA") for the 2021-22 winter Ice Hockey programs with Tenafly designated as the Lead Education Agency. This application has been submitted to cover a minimum of a 2-year period inclusive of the 2021-22 & 2022-23 seasons.
- 2. The agreement has been accepted by the Cooperative Sports Program (hereinafter "Program") by the NJSIAA, the Big North Conference and the New Jersey Interscholastic Hockey League and has been accepted by the aforementioned parties for a 2-year period inclusive of the 2021-22 & 2022-23 seasons.
- 3. This agreement shall be in effect for the 2021-22 Ice Hockey season.
- 4. Cresskill Public Schools agree to reimburse on a per student proportional basis for the total

expenditures associated with the Ice Hockey program; specifically Ice Rental, Coaches Stipends, Transportation, Tournament Fees and Officials for varsity contests. For the purpose of the 21-22 school year, Cresskill fiscal responsibility for their number of participants will be based on the roster of the aforementioned associated program based costs. Upon conclusion of the Ice Hockey Season, Cresskill Public Schools will remit reimbursement to the Tenafly Public Schools for costs assumed throughout the season.

- 5. The Head Ice Hockey coach and the Assistant Coach will be employees of the Tenafly Public School and subject to their evaluative procedures.
- 6. Transportation between Tenafly and program practices and games shall be provided by Tenafly. Cresskill shall provide transportation to and from Tenafly.
- 7. All program players agree to comply with all Tenafly policies and rules as well as any and all applicable NJSIAA rules and regulations governing competitive sports at the High School Level. Participation on the Tenafly Ice Hockey team is a privilege, not a right, and all rules regarding participation in the Program shall be applied equally to Tenafly and Cresskill Students.
- 8. Cresskill agrees to and shall save, keep harmless and indemnify Tenafly and its agents. employees and servants against any and all actions brought against Tenafly based on Cresskill's participation in the program for payments, expenses, and costs, including reasonable attorney fee, and liability for losses or damage to property or injuries to persons occasioned wholly or in part by, or resulting from any acts or omissions by Tenafly's agents, employees, and servants, except where there has been willful and wanton acts or omissions by Tenafly's agents, employees or servants.
