

BLEVINS SCHOOL BOARD MEETING
JUNE 13, 2022
CAFETERIA

The regular board meeting was held June 13, 2022 in the school cafeteria. The meeting was called to order at 6:30 p.m. by President Laura Clark. Board members present: Laura Clark; Carl McGill; Cindy Parks; Steve Dunham; and Dave Phillips.

Prayer was led by Carl McGill, and the Pledge of Allegiance was said by all.

The board went into executive session at 6:31 p.m. to discuss personnel issues. The board came out of executive session at 7:21 p.m.

Laura Clark made a motion to hire the following employees for the 2022-2023 school year: Weston Burgess as outside maintenance/mowing (240-day contract); Karen Tewalt as cafeteria worker (180-day contract); Crystal Domaloan as cafeteria worker (180-day contract); Ann McWilliams as cafeteria worker (180-day contract); Bill Putz as outside maintenance (240-day hourly contract — part-time for ½ day/4 hours); Alex Carter as elementary teacher (180-day contract); Tina Daughtery as elementary teacher (180-day contract); and Amanda Buck as elementary teacher (180-day contract). Cindy Parks seconded the motion. Motion passed with a 5-0 vote.

Laura Clark made a motion to accept the following resignations: Ashley Basham; Austin Driver; Katelyn Kirkham; and Tina Martin. Dave Phillips seconded the motion. Motion passed with a 5-0 vote.

Dave Phillips made a motion to approve the amended minutes for the May 9, 2022 board meeting (**corrected the purchase of High School Curriculum to reflect “...High School “Critical Reading”/Literacy Curriculum...”**). Carl McGill seconded the motion. Motion passed with a 5-0 vote.

Due to computer/internet issues, no financial reports for May 31, 2022 were available for board review (will review at July 11, 2022 board meeting).

Cindy Parks made a motion to approve the purchase service contract with Norman Hill Enterprises LLC from July 1, 2022 through June 30, 2023 for financial services. Dave Phillips seconded the motion. Motion passed with a 5-0 vote.

Laura Clark made a motion to approve the stipend addition for District Testing Coordinator (\$3,000.00 per year). Cindy Parks seconded the motion. Motion passed with a 5-0 vote.

Cindy Parks made a motion to accept the new/updated June board policies. Dave Phillips seconded the motion. Motion passed with a 5-0 vote.

Laura Clark made a motion to accept the bid from Kendall Hunt Publishing Company to purchase K-6 Illustrative Math curriculum for the 2022-2023 school year. Carl McGill seconded the motion. Motion passed with a 5-0 vote.

Dave Phillips made a motion to accept the bid from Savvas to purchase Literacy Curriculum for \$47,552.50 for grades 6-12. Steve Duncan seconded the motion. Motion passed with a 5-0 vote.

Cindy Parks made a motion to approve the \$6,945.60 purchase of Elementary Literacy Curriculum (Wit And Wisdom) teacher books from Great Minds (additional books for 3rd grade teachers). Dave Phillips seconded the motion. Motion passed with a 5-0 vote.

Cindy Parks made a motion to accept the \$20,198.50 bid from Brian Brown Consulting LLC to refinish the floors in the school (excluding cafeteria and high school building). Carl McGill seconded the motion. Motion passed with a 5-0 vote. **(NOTE: This was the only bid received).**

Steve Dunham made a motion to accept the \$6,624.48 bid from Southwest Sporting Goods to purchase helmets and shoulder pads for elementary youth football. Dave Phillips seconded the motion. Motion passed with 5-0 vote.

Dave Phillips made a motion to accept the \$50,225.00 bid from CDW to purchase 100 chromebooks and 19 charging carts. Carl McGill seconded the motion,. Motion passed with a 5-0 vote.

Steve Dunham made a motion to accept the Hempstead County Sheriff Office Agreement To Provide School Resource Officer For The Blevins School District for the 2022-2023 school year (\$35, 849.20 for August 11, 2022 through May 17, 2023). Dave Phillips seconded the motion. Motion passed with a 5-0 vote.

Cindy Parks made a motion to nominate Laura Clark to serve as board president until the May 2023 election. Dave Phillips seconded the motion. Laura was elected by a vote of 5-0.

Steve Dunham made a motion to nominate Carl McGill to serve as board vice-president until the May 2023 election. Carl was elected by a vote of 5-0.

Laura Clark made a motion to nominate Cindy Parks to serve as board secretary until the May 2023 election. Cindy was elected by a vote of 5-0.
