ACKNOWLEDGEMENT OF VISITORS

PAUL MONTEMURO

Mr. Paul Montemuro stated that our solicitor said we are wasting money on all the Right-to-Know requests. He also stated that there is \$2.5 million not billed for YSA. Mr. Montemuro noted that booster clubs must follow school policy. Mr. Montemuro said that in April Mr. Redline asked about the credit card and the Business Manager said that is was a District credit card. He added that he won an appeal and that if he does not receive records he will file a court order. He also asked where the free stuff that comes with the credit card is. He also noted that the District may not change the original document.

CINDY HENNING

Mrs. Henning stated that she was her last month and wanted to know whose name is on the credit card. She did receive the copies, but there was no name and things were redacted. She asked what was taken off. She added that she wants to see the credit card number. Mr. G Strubinger stated that the Business Manager's name was on the card. Atty. Mousseau stated it was redacted for confidential reasons. Mrs. Henning also asked

where the bill is sent. Dr. B. Gasper responded that it comes to the District Office.

ROBERT RENODE

Mr. Robert Renode addressed the Board to ask why kids are not allowed to bring water bottles to school. He stated that his daughter was hospitalized with dehydration and that the Principal said he prohibited it due to sanitary reasons. He is asking for the rule to be changed.

Dr. B. Gasper stated that students have access to water and that contraband has been brought to school and that is a reason why they are not allowed to have water bottles with them at all times.

Mr. Renode stated that water is a human right. Mr. T. Lesisko responded that students may bring water bottles to school but they need to stay in their lockers. He also stated that if students have a note from a doctor it will be honored and they will let the students have water with them.

Mr. Renode asked if there was a policy on this. Dr. B. Gasper said he will gladly look into it.

Mr. G. Strubinger asked if our fountains have a filter to fill up water bottles. Mr. T. Lesisko responded that they do not. Dr. B. Gasper noted that they are looking into a grant for this.
