Minda Jones moved and Galen Methvin seconded the motion to approve the following as stated.

- Recommend to approve a \$20.00 daily maximum for professional leave meal reimbursement.
- Recommend to approve a \$400.00 stipend for Highly Quality Student Data (HQSD) members beginning with the 2021-2022 school year.
- Recommend to approve January 10, 2022 at 5:30 p.m. as the date and time for the 2022 Organizational Board Meeting and appoint Galen Methvin as President Pro-Tem.

Roll call: Ayes – Craig Eiden, Minda Jones, Stephanie Mazur, Galen Methvin and Jennifer Caryer. Motion Carried 5-0.

Mrs. Jones asked about opening the new athletic complex to the public. Mr. Countryman informed the Baord that we are still waiting for the fobs to the new building to arrive. Mrs. Jones noted that she was not in favor of over-riding the fob access.

Mrs. Caryer – attended a Capital Conference session regarding student free speech.

Mrs. Jones – attended a session on poverty stating differences between urban and rural poverty districts noting that bullying is more prevalent in rural schools. Another session was about connections with one's community. A third session was about School Board goals and the health and wellness of students and staff.

Mr. Countryman would like the Board to think about creating a Special Education type of administrative position. Mr. Countryman is gathering information from other Districts including job descriptions and wages and would be approximatley a 193 day contract year. It was noted that if this position supervises other special education teachers then it would require an administrative license.

Mrs. Caryer thanked those in attendance for coming tonight. She reminded that anyone who plans to speak that you are not allowed to use any student or staff members name, and that you are limited to 4 minutes according to board policy.

Michael Villena spoke mentioning that they met with the Board at the last meeting in executive session as they felt their son was berated and emotionally and verbally abused in a meeting he had with the Guidance Counselor. He stated that his son had audio recorded the meeting with the Guidance Counselor in question because of the horror stories he had heard from others. The recording was shared with the administration and the Board at the last Board meeting and would play the recording now if anyone would like to hear it, a member/s from the Board/Administration stated "no".

Mr. Villena noted that they would like this Guidance Counselor to be suspended on a leave of absence while the Board and administration look into these ethical violations further and file our complaint with the Ohio School Boards Association's attorneys. Also feel that the teacher that was present at the meeting be suspended or placed on leave due to her responsibility and involvement in the emotional abuse of his son. His son isn't the first student to be verbally and emotionally abused by this Guidance Counselor, but they want him to be the last one. Mr. Villena mentioned that what was a voice for their son has turned into a voice for many that have been mis-treated by this Guidance Counselor.

Shannon Villena thanked everyone for their support. She repeated that her son's forethought to tape the meeting which she said lasted 15 minutes was based on comments from other kids. She stated that she knows that this Guidance Counselor has a lot of complaints against him. Mrs. Villena mentioned that someone had told her that their child had this happen to them as far back as 20 years ago. She asked, when will this be enough, when will this treatment stop? She feels it's in the best interest of our students that this Guidance Counselor be asked to part ways with our school. Mrs. Villena mentioned that it's sad but true that the teacher's union will protect him. She mentioned that someone told her that their child was called a stupid idiot.

Sue Hoffman, student's grandmother mentioned how this High School Counselor has abused students calling them names and bullying them over the years with his unethical practices and that it is hard to believe that we can let this guidance counselor continue.

Shawn Falls, Northwest Allen School District, non-resident of Hicksville mentioned that people need to speak up for our students, for ethics and morals and the right thing to do. This student is not doing well, and the Board needs to do something.

Becky Gregory mentioned that she heard the audio and has known the young man since he was born, noting that she was sick and appalled by the audio recording. From the audio she heard how cutting to the core of who he was, and he might as well said you are a worthless human being.

Lina Mendoza mentioned that her son was at the same incident as the Villena boy. She stated that her big issue and problem is adults were discussing punishments with our children without calling or texting us, they are still children, and we should have had a call from the school. Ms. Mendoza also mentioned that her son also was threatened to have certain privileges taken away that he had earned.

Danelle Myers mentioned when the incident happened on September 23rd, her son was also present on the night of the incident. She compared the loss of student privileges (Student Council and National Honor Society) from this incident to some athletes suspended because of alcohol but not suspended from Student Council and National Honor Society.

Denita Meyers, Northwest Allen County, non-resident of Hicksville says we have a very big opportunity to rectify situations, stating that her school is very divided because her school didn't do the correct thing when they had the opportunity. Parents must feel that their students feel safe and secure. She mentioned that this guy needs to be on leave

until the Board gets to the bottom of this. Also saying it's not conducive (it's repulsive) for this young man to have to go to school and see this gentleman every day.

Kennedy Villena said that she is standing up for her brother and that he doesn't make a big-deal out of something little. She knows this isn't the first-time students have been treated badly and won't be the last time if the Board doesn't do something about this matter. She mentioned that she was personally scared to go to him for college advice because she had heard multiple pupils say he feared them away from certain professions because they were too dumb or wouldn't be able to do it. She was surprised when he did support her decision.

Mrs. Caryer concluded by saying we appreciate public attendance and participation. At the same time, we must follow staff discipline regulations, due process, collective bargaining agreement and Ohio State law. Discipline matters in a public school is not a simple matter. We have heard your issues and will be discussing them with our attorney to help guide our next steps. Discipline issues will only be discussed in executive session and will not be done at open and public meetings. We will not be able to update you on these matters at this time.

Minda Jones moved and Craig Eiden seconded the motion to hold an executive session at this meeting in order to consider the appointment, employment, dismissal, discipline, demotion, or compensation of a public employee or official, or issuing suspension, or termination of a license, or the investigation of charges or complaints against a public employee, official licensee, or regulated individual unless the public employee, official, licensee, or regulated individual requests a public hearing.

Roll call: Ayes – Craig Eiden, Minda Jones, Stephanie Mazur, Galen Methvin and Jennifer Caryer. Motion Carried 5-0.

Mrs. Caryer noted that the Board will return from executive session with no further business other than to adjourn.

The Board entered executive session at 6:45 p.m. The Board exited executive session at 7:31 p.m.

Minda Jones moved and Galen Methvin seconded the motion to adjourn this meeting until the next board meeting to be held on Monday, November 22 at 5:30 p.m.
