Hicksville Exempted Village Schools Regular Meeting of the Board of Education September 20, 2021

The Hicksville Exempted Village Schools Board of Education met in regular session on Monday, September 20, 2021 at 5:30 p.m. in the Community Room. The meeting was opened by Vice-President, Craig Eiden, with the following Board members answering roll call: Stephanie Mazur, Galen Methvin, and Craig Eiden,. Minda Jones was absent.

Mrs. Caryer arrived at 5:33 p.m.

The following items were discussed by the technology director.

Mr. Shaffer - Technology Director

- Projector and sound system in commons and main gym looking to install after basketball season. ARP ESSER monies will pay for a most or all this project which will allow us to spread students out. Current projector in commons is ineffective and unreliable.
- Online payment system. Convience fee to be passed along to the consumer
- IPads for Board meetings anticipate beginning in October 2021.
 Minutes and Five-Year Forecasts will be loaded onto the IPads. Plan on meeting at 5:00 on the 18th of October to do initial training.

- OTES 2.0 professional growth plan has been started with MS staff
- Mrs. Chamberlain nearly complete with student testing
- Mrs. Andrea Diehl working with students on Community Service Project

Mrs. Coffman - Elementary School Principal:

- Growing Gods Way starts next Monday, 49 student currently registered in grades 1-4. Kindergarten to begin November 1st.
- 3rd grade guarantee diagnostics continuing with title services beginning within two weeks
- Mrs. Coffman noted that there is a shortage of substitute teachers but it is even worse with paras/aides. Current rate is \$9.00 per hour and would like the Board to consider increasing substitute pay for paras/aides in order to attract more candidates

After some discussion the Board arrived at the rate of \$100 per day considering a 7.5 hour day, or \$13.33 per hour.

- New building punch list being worked on
- Melissa Crawford to be brought on as new cafeteria mananger
- We're in need of bus drivers, Eric Bassett and John Adams have helped tremendously
- Administrative and technology teams reviewed the District's website
- Mr. Bassett, Mr. Adams and Mr. Countryman recently met with a representative of playground equipment and looked at the possibility of adding swings - moving from a single swing to a double swing. Have also inquired about the cost assoicated with adding a playground outside of the preschool classrooms with the hope of paying for it through grants.
