## Motion made by Ms. Faressa and Seconded by Mr. Malagutti:

## Recommendations of the Superintendent of Schools:

THE STUDENT shall be expelled, effective December 17, 2021, and continuing through December 8, 2022 (the "Expulsion Period"), under the following conditions:

The BOARD will provide THE STUDENT with an alternative educational opportunity deemed appropriate through the PPT process.

Prior to the beginning of the 2022-23 school year, the Superintendent will review THE STUDENT's conduct, attendance and effort level in the alternative educational opportunity, for the purpose of determining, in the

Superintendent's sole discretion, whether THE STUDENT should be readmitted to school on or about the first day of the 2022-23 school year. In order to be eligible for consideration for such early readmission, THE STUDENT must satisfy all of the following conditions:

THE STUDENT must make a good faith effort to succeed in the alternative educational opportunity during the period of expulsion, by attending and participating in the program regularly, completing assigned homework and other assignments in a timely manner and otherwise demonstrating a good faith effort to succeed in the program;

THE STUDENT must not engage in any conduct that would warrant suspension and/or expulsion under the policies of the Board as determined by the Superintendent;

If the Superintendent determines that THE STUDENT should be readmitted to school early in accordance with the preceding section, and if THE STUDENT subsequently commits any offense that would warrant suspension and/or expulsion under the policies of the Board, the Superintendent may reinstate THE STUDENT expulsion for the remainder of the expulsion period, through December 8, 2022, without the need for any further proceedings before the Board.

During the expulsion period, except as authorized in writing in advance by the Superintendent of Schools, THE STUDENT will not be permitted to be on school grounds and will not be permitted to attend or participate in any school-sponsored activities, with the sole exception of his participation in the alternative educational opportunity to the extent such alternative educational opportunity is provided on school grounds.

**Motion made by Mr. Malagutti and seconded by Ms. Faressa**: I make a motion to accept the recommendations from the Superintendent of Schools and the Administration as amended by the Watertown Board of Education.
