After World War I, three organizations joined efforts to improve literacy and physical education across the country. Draft boards had reported that 25 % of the drafted young men were illiterate and 29% unfit. Members of the American Legion, the U.S. Office of Education, National Education Association created a plan for a national observance. In 1921, they launched Nation Education Week during the first week in December.

Since then, the focus of the observance has changed. Where once the celebration aimed to eliminate illiteracy and improve physical fitness, the week evolved to incorporate new themes and goals.

The schedule for the week includes a teacher yard sale Monday and Tuesday from 3-6 pm at the Old Main Gym. The items include teacher materials left to us from deceased Reading Consultant, Kathy Snyder that she wanted our teachers to have. Some of the items were presented on opening day.

Also, schools were asked to make a AEW display. We had 3 schools participate, the following awards for their displays are: 3rd place, Birch River Elementary, 2nd place Gauley River Elementary, and 1st place Cherry River Elementary. Additional activities for the week: Dress like an educator, and dress for success."
