- a. **For Consideration: Set School Choice Student Enrollment Capacity for 2020-2021 School Year** - Chapter 76, Section 12 B (j), mandates a random selection process for school choice selection, "...one time prior to July first..." The statute (12Bc) also mandates, "...not later than May first of every year, the school committee of each city, town or regional school district shall submit a report to the Department of Education stating (1) the capacity of each school in said city, town, or regional school district for the following academic year." The motion below is designed to keep the district in compliance with this statute. A School Choice Analysis has been provided for committee review.

- b. **For Consideration: Set Foreign Exchange Student Enrollment Capacity for 2020-2021 School Year** – The Medway Public Schools are approved as a Student and Exchange Visitor Program through the Department of Homeland Security. The Medway Public Schools has the ability to issue I-20s as for a visiting student to obtain an F-1 Visa. The district needs to identify the number of Foreign Students to admit for the 2020-2021 school year.
