# American Rescue Plan (ARP) Act Elementary and Secondary School Emergency Relief (ESSER) Fund III Augusta County Public Schools Plan for Safe Return to In-Person Instruction and Continuity of Services

Updated: November 29, 2021

### **Section 1: Introduction**

The purpose of the American Rescue Plan (ARP) Act Elementary and Secondary School Emergency Relief (ESSER) III Fund is to help safely reopen and sustain the safe operation of schools and address the impacts of COVID-19 on the nation's students by addressing students' academic, social, emotional, and mental health needs. This plan describes how Augusta County Public Schools will maintain the health and safety of students, educators, and other school and division staff during and following the return to full in-person instruction. # Section 2: Maintaining Health and Safety

Augusta County Public Schools has taken and will continue to take actions to ensure the health and safety of students, educators, and other school and division staff during and following the return to full in-person instruction. A description of actions already taken and additional actions planned is below.

In addition, Augusta County Public Schools has adopted policies on each of the following safety recommendations established by the Centers for Disease Control and Prevention (CDC).

- Universal and correct wearing of masks
  - Masks are required in all our facilities regardless of vaccination status. This is communicated through the administrative policy manual, communication to parents, and proper signage through the school.
  - Masks are required to be worn except when actively eating or drinking.
  - Masks are optional in outdoor settings. However, people who are not fully vaccinated should wear a mask in crowded outdoor settings or during activities that involve sustained close contact with other people.
  - ACPS Transportation (buses and cars) require all students and drivers, whether vaccinated or not, to wear a mask while on the bus or in an ACPS car.

- Modifications to allow for physical and social distancing
  - ACPS will follow the CDC recommendations to maintain at least 3 feet of physical distance between students within classrooms to the greatest extent possible and possibly up to 6 feet when feasible.
  - o Seating in classrooms will be arranged to maintain as much distance as possible.
  - Alternate locations within the school building may be used to provide instruction; including the auditorium and gym.

#### Handwashing and respiratory etiquette

- References to proper handwashing and respiratory etiquette is followed as recommended by the CDC.
- ACPS enforces proper hygiene etiquette through posting of signs in our facilities, educating staff on techniques, and reminding parents through school communication notifications.
- Additional hand sanitizing stations have been installed at all facilities to provide additional availability for handwashing throughout the day.

# Cleaning and maintaining healthy facilities

- Facilities are cleaned once each school day. In addition, frequently touched surfaces are sanitized throughout the day.
- Appropriate disinfectant has been provided to staff to use in sanitization efforts within the classrooms.
- o Ventilation systems are updated, repaired, and improved as funding is made available.
- HVAC filter changes have increased to 6 times a year to improve air flow and quality within each facility.
- Water filling stations have been installed in the place of traditional water fountains, eliminating mouth contact and possible contamination.

#### Contact tracing in combination with isolation and guarantine

- Contact tracing will be conducted as required.
- o All close contacts (for the purpose of quarantine) will be referred for testing.
- Quarantine will be based on distance of contact, length of time of exposure, the correct wearing
  of well-fitting masks during exposure, vaccination status, and symptoms. Additional information

- Any person who tests positive or is identified by a medical professional as being suspected of having COVID-19 and whose activities might have resulted in exposure to others in the school environment should report their positive status to ACPS in order to permit contact tracing, to maximize the safety of others and to minimize outbreaks that may interfere with continued in-person instruction.
- ACPS will continue to collaborate with local health departments, to the extent allowable by
  privacy laws and other applicable laws, to confidentially provide information about people
  diagnosed with or exposed to COVID-19. This allows identifying which students, teachers, and
  staff with positive COVID-19 test results should isolate, and which close contacts should
  quarantine.
- ACPS will report, to the extent allowable by applicable privacy laws, will notify teachers, staff, and families of students who were close contacts as soon as possible after ACPS notified that someone in the school has tested positive for COVID-19.

- Diagnostic and screening testing
  - Daily health screening (questionnaire) are expected to continue to occur at home before the employee or student leaves their residence. Daily Health Screenings can be found on the ACPS website: https://augustava.sites.thrillshare.com/page/covid19
  - Daily temperature checks should be monitored by families as needed at home (e.g. when there
    are symptoms of illness or fever). School nurses will take temperature checks as needed at
    school.

## Vaccination efforts

- ACPS in coordination with our local and state health department have offered vaccination clinics for all staff members. In coordination with our local health facilities, ACPS has assisted in coordinating vaccines to related parties of the school community, including but not limited to, eligible students, family members, and child care providers. ACPS also hosted two locations for school employees to receive their booster vaccinations for Covid 19.
- Free Vaccination Clinics for Augusta County Schools in collaboration with the Central Shenandoah Health Department will be hosting 2 vaccine clinics. Clinics will be held on Aug. 9 at Wilson Middle school from 9 to 12 and Beverly Manor Middle from 2-5pm. and include Tdap, Meningitis, HPV and Pfizer Covid Vaccine. You do not have to register, however, registration forms will be available at your school to fill out prior to help save time. Pfizer Covid Vaccines are free to all. Other vaccines may be filed with student insurance if applicable.
- ACPS hosted two sites for students 12 years old to 18 years old to receive their Covid 19 vaccination.
- Vaccination clinics for students 5 years to 11 years old will be held on the following dates:

- Appropriate accommodations for children with disabilities with respect to health and safety policies
  - In coordination with parents and their medical provider, ACPS provides both safety and education objectives based on each students' individual need. Specific disabilities are addressed when determining appropriate safety measures for each student. As needed, learning opportunities are adjusted to align with those appropriate safety measures.
- Coordination with State and local health officials
  - ACPS continues to hold weekly meetings with both our State (Virginia Department of Health)
    and local (Central Shenandoah Health District) districts regarding current COVID-19 protocols,
    guidelines, cases, and trends. These meetings have been used to guide health and safety
    protocols in the schools and help in mitigation strategies against COVID-19.

# **Section 3: Continuity of Services**

Augusta County Public Schools has taken and will continue to take actions to ensure continuity of services, including but not limited to, services to address students' academic needs and students' and staff social, emotional, mental health, and other needs. Appropriate accommodations for children with disabilities with respect to health and safety policies (accommodations will be determined on an individual basis through the child's Individualized Education Program (IEP) or \$504 plan.)

Beginning on August 10, 2021, all Augusta County Schools have provided in-person learning for five (5) days per week with a minimum of six instructional hours per day. A small percentage of high school students (grades 9-12) are continuing to learn virtually in response to medical needs or to accommodate work schedules initiated during the pandemic. Teachers are continuously evaluating students' preparedness for learning using Virginia Growth Assessment data, guided reading levels, and pre-/post-test data and adapting instruction accordingly. Schools are also providing additional opportunities for after school tutoring and homework support. Students with disabilities are also attending school five (5) days a week and continue to progress on their IEP goals. An instructional specialist has been added to the student services office to help with the instructional needs of students with disabilities. We have added 2 new social work positions in support of families and social emotional needs of students. Family and School Engagement is one position that works with reengaging and keeping families engaged in school, including attendance. Social Emotional support is being delivered and coordinated with a new position. This position works with students and staff on the needs of students' mental health, including coordinating community support, TDT, and specialized school support. ACPS has hired 4 behavior technicians to work with high needs students who are struggling to self regulate. We continue to look for ways to support our students with instructional, behavioral, and social emotional needs.

# **Section 4: Opportunity for Public Comment**

In developing the ARP ESSER Plan, Augusta County Public Schools sought public input and took such input into account as described below.

Augusta County Public Schools presented a return to in-person learning plans/updates at the following public meetings of the Augusta County School Board and heard public comments on 6/3/2021, 7/1/2021, 8/5/2021. During those presentations there were opportunities for community members and stakeholders to provide input into the plan. The public will continue to have opportunities to make comments at each regularly scheduled meeting held the first Thursday of each month at 7:00 pm. ACPS also sought input from a task force consisting of community stakeholders with differing backgrounds related to public education. Their input was significant in offering a hybrid approach to learning throughout the 2020-2021 school year and addressing changing health guidance to offer a full in-person learning model for the 2021-2022 school year. Community members, parents, school counselors, and social workers all provided valuable input representing the interests of children with disabilities, English learners, children experiencing homelessness or in foster care, migratory students, and other underserved students.

#### Section 5: Periodic Review and Revision of the Plan

During the period of the ARP ESSER award (until September 2023), Augusta County Public Schools will periodically review and, as needed, revise its plan for the safe return to in-person instruction and continuity of services. The plan will be reviewed at least every six months, and Augusta County Public Schools will seek and take into account public input during the review process. Plan revisions will address updated CDC guidance on safely reopening schools, if any are issued.
