Items from Board

Board Treasurer

Currently our State legislature is working in a lame-duck session. A lame-duck session occurs whenever a legislature meets after its successor is elected, but before the successor's term begins.

Our State legislature is currently working on three big items that impact public education but will most likely not be voted on during lame duck, which ends December 15th. All three items are likely to re-emerge in next year's session starting in January 2017.

1 - MPSERS Tax Shift Stall

Senate Bill 102 was introduced to close the MPSERS hybrid pension system for new employees and move those new employees to something similar to a 401(k). The Michigan Senate Fiscal Agency reports the cost of the legislation at \$1.6 billion to \$3.8 billion over five years.

2 – Accounting Change in Income Tax Refunding

The Governor put forth an idea to change the distribution between the State's General Fund and School Aid fund related to the way income tax is refunded. This proposed change would reduce School Aid Fund (SAF) revenue by over \$400 million. As it stands now about 24% of Income Tax Collections are placed in the SAF with all income tax refunds coming from the General Fund. The Governor is considering a change to have a portion of those refunds come from the SAF instead.

3 – Energy Plan

There is still life in the plan to effectively eliminate electric choice programs in Michigan. DTE and Consumers would like the House of Representatives to vote on Senate Bill 437 which reduces the ability to

purchase electricity from providers other than DTE and Consumers. Huron Valley Schools currently saves an estimated \$400,000 annually on purchasing electricity on the open market.

Huron Valley Schools will be following this legislation closely as we move out of lame duck and into the new legislative year.

Mr. Carlson encouraged the community to contact their legislatures and ask them to stop taking money away from the School Aide Fund.

Mr. Long talked about the Department/Committee structure and which Board Members would be on those committees. With new members coming on the Board in January, Mr. Long has updated the Board to Building Ambassadors.

Denise Forrest, President of the HVEA, thanked the outgoing Board Members. Ms. Forrest explained how the State of Michigan took back \$470 per pupil several years ago and has never given that amount back to public schools. She urged the community to contact their legislatures and tell them to stop taking away School Aide Fund dollars from public education.
