Information from the Board President

Board Treasurer

Governor Snyder's budget, as presented on February 10th, is now being reviewed by the House and Senate Fiscal Agency Committees. Briefly, the Governors proposed budget calls for an increase in the foundation allowance for Huron Valley Schools of 1.6%. However, that increase will be offset by rising expenditures and the lower number of pupils anticipated within the district next year. The Governor's budget proposal is one step in the process of developing the Huron Valley Schools budget for next year. The next step will be to:

- 1. Obtain the House and Senate version of their proposed budgets which are anticipated
- 2. Obtain the results of the May 2016 Consensus Revenue Estimating Conference, as well as
- 3. Determine local budget impact, such as class offerings, health care changes, etc.

Both the House and Senate Appropriations subcommittee continue to discuss the K-12 budget. The meetings are focusing on various programs and changes currently included in the Governor's proposed budget.

The House Appropriations Committee took more testimony last week on the House Republican plan (House Bills 5382-81) to deal with the Detroit Public School financial crisis the Senate did not take action on its version of the DPS bills.

On a final note

This past week, our legislators spent time preparing for an/or being a part of the Republican debate held on Thursday, March 3, 2016 in Detroit as well as the Democratic debate held on Sunday, March 6, 2016 in Flint.
