The Hoxie School Board met for their regular school board meeting on Monday, April 20, 2020 with all members present. President Nathan Romine called the meeting to order at 6:05 pm. (Visitors joined via Zoom at 6pm- Tracy Gates, Kim Washburn, and Darlene Shoe)

A motion was made by Mr. Gates and seconded by Mr. Coats, with a 5-0 vote to accept the minutes as read from the regular March meeting held on March 9, 2020 at 6:00 pm.

A motion was made by Mr. Dobbs and seconded by Mr. Worlow, with a 5-0 vote to approve the Financial Report as presented by Superintendent Gillham.

Mr. Coats made a motion that was seconded by Mr. Gates with a unanimous decision (5-0), to approve the 2020-2021 Classified Salary Schedule.

Mr. Gates made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to approve the 2020-2021 Supplemental Salary Schedule.

Mr. Worlow made a motion that was seconded by Mr. Coats with a unanimous decision (5-0), to approve reimbursement of the Bus Driver Testing Fee effective immediately.

Mr. Worlow made a motion that was seconded by Mr. Coats with a unanimous decision (5-0), to hire Cory Watson as Head Boys Basketball Coach for the 2020-2021 school year.

Mr. Dobbs made a motion that was seconded by Mr. Gates with a unanimous decision (5-0), to hire Cheryl Englert as Assistant Softball Coach for the 2020-2021 school year.

Mr. Coats made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to hire Jessica Powell as Student Council Sponsor for the 2020-2021 school year.

Mr. Gates made a motion that was seconded by Mr. Coats with a unanimous decision (5-0), to hire Andrea Vancil as Concession Stand Manager for the 2020-2021 school year.

Mr. Gates made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to approve the student transfer of one student from the Paragould School District to the Hoxie School District, one student from the Green County School District to the Hoxie School District for the 2019-2020 school year.
