A motion was made by Mr. Gates and seconded by Mr. Coats, with a 5-0 vote to accept the minutes as read from the regular May meeting held on May 11, 20, 2020 at 6:00 pm and the May Special Board Meeting held on May 28, 2020 at 5:05 pm.

A motion was made by Mr. Dobbs and seconded by Mr. Worlow, with a 5-0 vote to approve the Financial Report as presented by Superintendent Gillham.

Mr. Worlow made a motion that was seconded by Mr. Gates with a unanimous decision (5-0), to approve the HSR student accident and catastrophic insurance for the 2020-2021 school year.

Mr. Coats made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to approve Arkansas School Board Association mobile equipment, vehicle and property insurance for the 2020-2021 school year.

Mr. Gates made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to hire Cannan Craig as elementary teacher for the 2020-2021 school year.

Mr. Worlow made a motion that was seconded by Mr. Gates with a unanimous decision (5-0), to hire Jordan Bigger as elementary teacher for the 2020-2021 school year.

Mr. Coats made a motion that was seconded by Mr. Worlow with a unanimous decision (5-0), to hire Carinna Coletti as elementary teacher for the 2020-2021 school year.

Mr. Worlow made a motion that was seconded by Mr. Gates with a unanimous decision (5-0), to hire Amy Barnhill as elementary parent facilitator for the 2020-2021 school year.

Mr. Dobbs made a motion that was seconded by Mr. Coats with a unanimous decision (5-0) to approve the transfer of two students from Hoxie School District to the Pocahontas School District for the 2020-2021 school year.
