The Hoxie School Board met for a special school board meeting on Friday, March 29, 2019 with all members present. President Dobbs called the meeting to order at 6:00 pm.

PPC President, Randall Puckett was the spokesperson for the Personnel Policy Committee, he stated that the PPC had viewed the proposed certified salary schedule for the 2019-2020 school year for 10 business days and they had no questions or comments about the proposed salary schedule. He asked if the school board had any questions for PPC and they did not.

A motion was made by Mr. Romine and seconded by Mr. Worlow, with a unanimous vote, the board approved the certified salary schedule for the 2019-2020 school year.

A motion was made by Mr. Worlow and seconded by Mr. Coats, with a unanimous decision, to accept the resignations of Dunia Schweri as elementary teacher, effective the end of 2018-2019 school year.

A motion was made by Mr. Gates and seconded by Mr. Coats, with a unanimous decision to accept the resignation of 5 contract days per her request, from April Britt, beyond the 190-day contract for the current 2018-2019 school year.

A motion was made by Mr. Worlow and seconded by Mr. Gates, with a unanimous decision to approve 17 students who have applied for school choice to the Hoxie School District for the 2019-2020 school year.

The board went into executive session at 6:12pm to discuss personnel. The board returned from executive session at 7:28pm with the following action:

Mr. Worlow made a motion that was seconded by Mr. Romine, with a unanimous decision, to hire all administrators who wish to return for the 2019-2020 school year.

Mr. Gates made a motion that was seconded by Mr. Coats, with a unanimous decision, to hire Larry Forrester as a part-time Dean of Students, ALE Director, and part-time interventionist for the 2019-2020 school year.

Mr. Coats made a motion that was seconded by Mr. Worlow, with a unanimous decision, to hire Cory Watson as Sr. High Boys Basketball Assistant, Jr. High Boys Basketball Assistant, and 7th Grade Boys Coach for the 2019-2020 school year.

Mr. Worlow made a motion that was seconded by Mr. Gates, with a unanimous decision, to hire Mike Chipman as the Sr. High Head Boys Basketball, Jr. High Head Boys Basketball, and 7th Grade Boys Basketball Coach for the 2019-2020 school year.

Mr. Coats made a motion that was seconded by Mr. Gates, with a unanimous decision, to hire Kimberly Endsley as Jr. High Cheer Coach for the 2019-2020 school year.

Mr. Romine made a motion that was seconded by Mr. Worlow, with a unanimous decision, to hire all certified personnel who wish to return for the 2019-2020 school year.

Adjourn: A motion was made by Mr. Worlow and seconded by Mr. Coats with a unanimous decision to adjourn at 7:33pm.
