Prices quoted are to be F.O.B. Hemlock, MI. All purchases are to be exempt from all taxes, including state and federal taxes. Exemption certificates will be furnished upon request.

Bids shall be firm for ninety (90) days from the date of the bid opening.

HEMLOCK PUBLIC SCHOOL DISTRICT CONCRETE PATIO BID

1.0 - SPECIFICATIONS

- 1.1 Specifications and plans are the minimum accepted standard. Alternates will be accepted for evaluation only. The primary bid shall be as specified in these documents.
- 1.2 The Board of Education reserves the right to accept or reject any or all bids, to waive any informalities therein, or to award the contract to other than the lowest bidder, which is in the best interest of the District. We reserve the right to delay the opening of bids.
- 1.3 Contractor shall submit appropriate documents of insurance (Certificates of Acord): Worker's Compensation \$100,000; Liability \$300,000; coverage pertaining to vehicles, property damage and public liabilities, personal injury, etc., and shall hold the school district harmless in any incident involving the contractor, his employees, his equipment, and vehicles.
- 1.4 Bidders shall visit the building area and familiarize themselves with the scope of the project. Project locations are as follows:

K.C. Ling Elementary School 835 N Pine St Hemlock, MI 48626

Hemlock Middle School 525 N Maple St Hemlock, MI 48626

- 1.5 The contractor shall submit a list of three (3) references complete with names, address, phone number and a contact person which will allow the Owner to verify ability to meet the terms of this document.
- 1.6 The contractor shall provide items of a minor nature, not specifically noted in these specifications, so as to provide a complete, operable and Owner acceptable installation.
- 1.7 Following award of the contract, work may commence on or after a mutually agreed upon date and must be completed before August 1, 2022.
- 1.8 The contractor shall clean their job area daily and dispose of all trash and debris leaving the area broom clean. **The Owner's dumpster is not to be used for contractor's trash.**

- 1.9 Contractor shall be responsible for compliance with all local, state and federal codes for the storage, handling and disposing of materials.
- 1.10 Contractor should bid each location individually for consideration. Contractor may also provide a multiple project bid to discount the project cost.

2.0 - SCOPE OF WORK:

- 2.1 K.C. Ling Elementary School four (4) stamped concrete patios approximately 12 ft x 24 ft
- 2.2 Hemlock Middle School two (2) stamped concrete patios approximately 12 ft x 24 ft and one (1) stamped concrete patio approximately 16 ft x 30 ft
- 2.3 Remove all existing grass, soil, and asphalt.
- 2.4 Concrete shall not be placed during rainy or threatening weather or when the moisture on the surface would prevent satisfactory setting. Do not pour when the air temperature is below 40 degrees F.
- 2.5 Grade to allow drainage away from buildings and prevent water from entering building.
- 2.6 Install 4" with 400 psi. Base prep, form, reinforcement, pouring of concrete, stamping, and sealing expected.
- 2.7 The flatness of the finished product shall have a maximum variation of 1/8" measured with a ten (10') foot straight edge. Areas that fail to conform to this standard shall be repaired at no additional cost to the Owner.
