### 0215. Oath of Office

The Oath of Office was recited by newly appointed school board member, Andrea Eagle Bull, who will complete the vacated term of office of Laticia DeCory, until July, 2022.

#### 0216. Approval of Agenda

Motion by O'Bryan, seconded by Eagle Bull to approve the Agenda, as presented. Motion carried unanimously. (Attachment A)

#### 0217. Conflict of Interest

Acting Superintendent, Connie Kaltenbach, reported no conflicts of interest reported by School Board members.

## 0218. Approval of Meeting Minutes

Motion by O'Bryan, seconded by Two Crow to approve minutes of October 25, 2021 regular meeting; and September 30, 2021; November 2, 2021; November 10, 2021; and November 24, 2021 special meetings. Motion carried unanimously.

## 0219. Reports

The School Board acknowledged receiving written reports from Principals and Program Directors, and verbal updates were provided.

The Board requested the Human Resource Office to consider appointing a committee within the certified and classified employees who will consider employee benefits.

### 0220. Student Oratory

Luta Keegan, Lakota Tech High School Student Council President, was in attendance and recited her indigenous poetry for the school board and those in attendance.

## 0221. <u>Construction Report</u>

Mr. Toby Morris, Construction Financial Consultant, provided information in regard to the teacher housing project currently being constructed, which will be located near the Wolf Creek School site. He also provided information in regard to future improvements to be made at Wolf Creek School, Lakota Tech and the Wolf Creek Bus Barn. Mr. Morris also updated the Board on status of discussions with Oglala Lakota County Commissioners in regard to the water situation at Wolf Creek School/Lakota Tech High School site.

#### 0222. Executive Session

Motion by O'Bryan, seconded by Conroy to go into executive session at 5:16 p.m. to discuss personnel. Motion carried unanimously.

President Blue Bird declared executive session ended at 6:47 p.m. and reconvened into regular session.

#### 0223. Enrollment Data

Connie Kaltenbach provided a visual chart to the school board, depicting school district student enrollment data, per each school, as well as district-wide.

## 0224. Teacher Shortage

Discussion was held in regard to the teacher shortage throughout the school district, particularly in the high school. The Board requested administration to report back at the December board meeting, after having developed a plan to propose for adjustment to the district's substitute pay schedule. The Board will review the recommendations at that time.

### 0225. Relocation Update

Connie Kaltenbach, Acting Superintendent, informed the School Board of the plan for administrative office employees to relocate to available office space within the Batesland School building.

### 0226. Teachwell Contract

Ms. Kaltenbach presented a contract for Teachwell to provide speech services to students of the school district three days per week, beginning January, 2022, through the end of the school term.

#### 0227. <u>First Peoples Fund MOU</u>

Alberta Wright, Lakota Tech Assistant Principal, presented a Memorandum of Understanding with First Peoples Fund, who will provide an instructor for 8 to 10 hours per week, at no cost to the school district, to provide high school students with opportunity to explore the arts, both written and oral.

### 0228. BHSU Partnership

Alberta Wright, Lakota Tech Assistant Principal, provided the school board with information regarding a request from Black Hills State University for the OLCSD to provide a letter of support. The Board will consider once written documentation can be provided.

## 0229. Financials

Sophia Conroy, Business Manager, provided an update in regard to the monthly financial report, along with a listing of expenditures, for the School Board's review. Discussion was also held in regard to bonding of employees.

### 0230. <u>Lakota Nations Invitational</u>

Administration reported on a conference presentation being offered by John Forkenbrock in regard to Impact Aid. This presentation will be offered during the Lakota Nations Conference in Rapid City, on December 14, 2021. School Board members were invited to attend. Board members were also updated in regard to student participation in the Lakota Nations Invitational through sports, Hand Games, Language Bowl and Archery.

## 0231. <u>December Board Meeting</u>

The Board discussed adjusting the date for the December regular meeting from Monday, December 20, 2021, to Tuesday, December 21, 2021.

Motion by O'Bryan, seconded by Eagle Bull to approve the construction report, as presented by Mr. Toby Morris, Construction Consultant. Further, to approve items "A through G" as recommended and listed:

Motion by Two Crow, seconded by Conroy to approve a Memorandum of Understanding with First Peoples. Motion carried unanimously.

### 0235. Financial Report/Disbursements

Motion by O'Bryan, seconded by Two Crow to approve the financial report and expenditures, as presented by the Business Manager, tabling the bond issue until next meeting. Motion carried unanimously. (Attachment C)

### 0236. Personnel Recommendations

Motion by Conroy, seconded by Two Crow to approve personnel recommendations, as presented. Motion carried unanimously. (Attachment D)

#### 0237. Staff Bonus
