Board member Justin Frank moved to approve Employment, accept resignations/retirement and Approve transfer of duties. These included: Employment: Mitch Baumchen–emergency substitute, Landry Cogburn–substitute teacher and Clint Thompson–Transportation Director. Jerome Hess seconded. Motion carried 5-0

Mr. Starnes informed Board members about the \$4,075 check from EMC-City of Alma's insurance company for damages from the ice storm last year. Mr. Starnes asked the board, due to district population changes we may need to look at redrawing our BOE member districts.
