The Board of Education of the School District of Marshall met in special session on Tuesday, January 11, 2022 at Spainhower Primary at 6:00 p.m.

Renovation of MHS was discussed. Dr. Carol Maher reported the timeline for the communication with DESE was as follows:

- December 2- Initial letter of attendance waiver request
- December 2 DESE approval of waiver request
- January 4 Email requesting extension (later denied)
- January 5 Phone conversation of denial
- January 6 Confirmation of email
- January 7 Phone call and letter submission to DESE
- January 10 DESE approval of revised plan
- January 11 Plan presentation to board and community

Delivery of instruction and student learning was discussed by Christy Jones, MHS Principal. MHS students will be located in the following locations:

- Marshall High School Freshman, 225
- Fairgrounds Sophomores, 185
- SCCC & Martin Center, Juniors and Seniors, 358 (students who take a 3 hour block class will be located at the SCCC)

Marshall High School will be the hub for transportation. Students who walk or ride the bus will continue to come to the high school and they will be transported to the location they are to attend. Student drivers will be allowed to drive to their location.

Breakfast will be at Marshall High School and lunch will be served at all four locations.

Courses offered will be as follows:

- Dual credit courses offered by MHS teachers
- SCCC Block courses offered by MPS CTE teachers
- Some MHS electives offered by MHS teachers
- Edmentum virtual platform will be used MHS teachers will support and enhance
- Credit recovery delivered through Acellus MHS teachers will support
- Band, jazz band and orchestra will be located at BMS. Vocal music will be rearranged at MHS and they are working on art and drama schedules.

There will be no school for MHS students on Friday, January 14, as the day will be used for training for MHS teachers on the Edmentum program. Brain Wilcoxson noted that the Saline County Career Center will hold classes on Friday. The SCCC 2 hour block classes and 3 hour block classes will still be holding classes, in person, at their regularly scheduled times as we have been since the fire. These classes include Building Trades (3 hour AM), Construction Skills (2 hour PM), Health Science (3 hour AM and PM), Automotive Technology (3 hour AM and PM), Culinary Arts (3 hour AM), Intro to Bakery & Pastry (3 hour PM), Teaching Professions (3 hour AM), and AG Construction 1 and 2 (2 hour PM). If a student has a transportation need that is different from what we have been doing, they need to contact the Saline County Career Center (660) 886-6958 and we will work to meet their needs.

Travis Stickels, General Manager of ServPro, gave an update on their services at the high school. Dr. Maher stated the district is hoping to be back in the high school by March 22.
