1. Preliminary:

- A. The meeting was called to order by President Nikki Shannon at 6.35 p.m.
 - a. Roll Call: Brandie Jackson, Tate Watkins and Nikki Shannon. John Cranson joined at 9:30 p.m. Others present, Paul Blanford Superintendent, and Dayna Davis.
 - b. The Pledge of Allegiance was led by Mrs. Shannon
- B. Approval of the Agenda Add Under action item E Approve Resignation Letter.

- 4. Superintendent Report Paul Blanford:
 - A. Education
 - a. High school is on the "Tech Tour" this week.
 - b. Gerry from "I Learn" has been assisting Mr. Blanford and talking about our school focusing on mentoring each student, championing their skills and providing guidance for their future. Options to explore are Charter school or Innovation.
 - c. If Kim school wanted to transport students from Otero County to Kim, the Kim School Board would have to have the school board approval from the Otero County School. If students were picked up at the boundary line there would be no need for permission. To cross through Bent County, Kim School, as a courtesy would need to let Las Animas School District know that we were traveling through their district.
 - d. Ag Teacher Position There is some interest but no applications at this time.
 - e. Nursing Grant Kim School received this grant which covers the current nurses full pay plus some extra to assist with her student loans. She is getting her masters as a nurse practitioner and she would like to continue working as our nurse and eventually work as a nurse practitioner in our area.
 - f. E Rate Money We will be receiving up to \$50,000 on the category two funding. This grate will help pay for technology costs. We also were awarded the category one funding which will go towards internet connectivity.
 - g. ESER Funds will need to be utilized in the next two years. We are currently looking at Health Curriculum, Playground Enhancements, Fit Watches and PE Equipment.
 - B. Facilities/Maintenance:
 - a. Boilers and Hot Water heaters were inspected and good for next two years.
 - b. Middle and High School students helped clean out bus shed. They are still planning on doing some cleaning in the old school and picking up around the campus.

- c. Demo on the Brown house has been delayed due to weather; however, Mrs. Shannon reports that the contractor notified her that he would begin work on Thursday, March 24, 2022.
- d. Elementary has been asking for a wind break. There has been a suggestion to put up a six-foot vinyl fence across the playground area. That would come out of the Make It Happen grant. Also looking at a cement sandbox. Have requested bids for those projects.

C. Activities:

- a. Basketball seasons are completed.
- b. Track will be out of Branson this Spring. We will be transferring some of our equipment to Branson and will ensure it is labeled.
- c. Local families will be working on recreation baseball this summer.

D. Technology:

a. Desktops are upgraded and network is getting re-established. Mr. Blanford is currently looking at options for student laptops for next school year.

- G. School of Innovation or Charter School: Mr. Blanford is still looking into options of a Charter School verses the Innovation School for Kim School. School of Innovation is less stringent to start. The District its self can apply for the applications, a Charter School cannot be done by the School Board, you have to form a separate Group to accomplish it.
